Education Act 2015
Education Regulations 2015

Determination of Fees: International Students and Distance Education Centres

I, Eva Dina Lawler, Minister for Education:

- (a) under regulation 14(1) of the *Education Regulations 2015*, and with reference to section 67(1) of the *Education Act 2015*, determine that the fees payable by international students enrolled in Government schools in 2024 are:
 - (i) for education services provided by a Government school to an international student with a visa of a subclass specified in Schedule 1, Part A or Part B:
 - (A) for a year at a year level specified in Schedule 1 for the subclass – the fee specified opposite in Schedule 1 for the year level; or
 - (B) if the student is enrolled at a Government school for less than a year – the fee referred to in subparagraph (A) adjusted on a pro-rata basis; and

- (ii) for the provision to an international student of facilities or arrangements for the student's accommodation:
 - (A) a fee of \$225 each time the student is placed in accommodation;
or
 - (B) if the student is placed in homestay accommodation – a fee of \$310 for each week the student is in homestay accommodation; and
- (b) under regulation 14(2) of the *Education Regulations 2015*, and with reference to section 69(1) of the *Education Act 2015*, determine that the fees payable for the provision of education services by distance education centres to a student of a class mentioned in section 69(1) of the Act are:
 - (i) for a year at a year level specified in Schedule 2 – the fee specified opposite in Schedule 2 for the year level; or
 - (ii) if the student is enrolled at a Government school for less than a year – the fee referred to in subparagraph (i) adjusted on a pro-rata basis.

 - (i) Friday 5 July 2024 (Alice Springs Regional Show Day);
 - (ii) Friday 4 July 2025 (Alice Springs Regional Show Day);
 - (iii) Friday 3 July 2026 (Alice Springs Regional Show Day);
- (e) for the part of the Territory described in Schedule 5 –
Friday 16 August 2024 (Borroloola Regional Show day).

Schedule 1

All that parcel of land in the Northern Territory of Australia described as follows:
the part of the Northern Territory of Australia north of the parallel of south latitude 13 degrees 34 minutes and of the parts of the Northern Territory of Australia being the whole of the Anindilyakwa area described in Schedule 6 to the *Aboriginal Land Rights (Northern Territory) Act 1976* (Cth) and the whole of the Daly River area described in Schedule 1, Part 1 to that Act.

Schedule 2

All that parcel of land in the Northern Territory of Australia bounded by lines described as follows:

commencing at the intersection of the parallel of south latitude 13 degrees 34 minutes with the sea coast of the Gulf of Carpentaria; thence generally southerly and south-easterly by the said sea coast to intersect the parallel of south latitude 15 degrees 30 minutes; thence west by the said parallel to intersect the meridian of east longitude 135 degrees; thence south by the said meridian to intersect the easterly prolongation of the northern boundary of Northern Territory Portion 2845; thence westerly by the said prolongation, the northern boundary of Northern Territory Portion 2845 and part of the northern boundary of Perpetual Pastoral Lease 1003 (Cattle Creek) to intersect the meridian of east longitude 132 degrees; thence south by the said meridian to intersect the easterly prolongation of the northern boundary of Pastoral Lease 826 (Suplejack); thence westerly by the said prolongation, the northern boundary of Pastoral Lease 826 and its westerly prolongation to intersect the meridian of east longitude 129 degrees being Northern Territory and Western Australia border; thence north by the said meridian to intersect the sea coast of the Timor Sea; thence generally easterly by the said sea coast to intersect the left bank of the Fitzmaurice River; thence generally easterly by the said left bank to intersect the southerly prolongation of the most easterly boundary of Northern Territory Portion 1637; thence northerly, westerly and again northerly by the said prolongation, an eastern, a northern and an eastern boundary of the said Portion to intersect the parallel of south point of commencement, thence easterly by the said parallel to the point of commencement, and including all Northern Territory of Australia coastal islands between the parallels of south latitude 13 degrees

34 minutes and 15 degrees 30 minutes, but excluding therefrom all islands within the Anindilyakwa area described in Schedule 6 to the *Aboriginal Land Rights (Northern Territory) Act 1976* (Cth).

Schedule 3

All that parcel of land in the Northern Territory of Australia bounded by lines described as follows:

commencing at the intersection of the parallel of south latitude 21 degrees 12 minutes with the meridian of east longitude 138 degrees being a point on the Northern Territory and Queensland border; thence west by the said parallel to intersect the meridian of east longitude 132 degrees; thence north by the said meridian to intersect the northern boundary of Perpetual Pastoral Lease 1003 (Cattle Creek); thence easterly by part of the said boundary, the northern boundary of Northern Territory Portion 2845 and its easterly prolongation to intersect the meridian of east longitude 135 degrees; thence sought by the said meridian to intersect the parallel of south latitude 18 degrees 30 minutes; thence east by the said parallel to intersect the meridian of east longitude 138 degrees being the Northern Territory and Queensland border; thence south by the said border to the point of commencement.

Schedule 4

All that parcel of land in the Northern Territory of Australia bounded by lines described as follows:

commencing at the intersection of the parallel of south latitude 21 degrees 12 minutes with the meridian of east longitude 138 degrees being a point on the Northern Territory and Queensland border; thence south by the said meridian to intersect parallel of south latitude 26 degrees being the south-eastern corner of the Northern Territory; thence west by the said parallel to intersect meridian of east longitude 129 degrees being the south-western corner of the Northern Territory; thence north by the said meridian to intersect the westerly prolongation of the northern boundary of Pastoral Lease 826 (Suplejack); thence easterly by the said prolongation, the northern boundary of Pastoral Lease 826 and its prolongation easterly to intersect meridian of east longitude 132 degrees; thence south by the said meridian to intersect parallel of south latitude 21 degrees 12 minutes; thence east by the said parallel to the point of commencement.

Schedule 5

All that parcel of land in the Northern Territory of Australia bounded by lines described as follows:

commencing at the intersection of the parallel of south latitude 18 degrees 30 minutes with the meridian of east longitude 138 degrees being a point on the Northern Territory and Queensland border; thence west by the said parallel to intersect the meridian of east longitude 135 degrees; thence north by the said meridian to intersect the parallel of south latitude 15 degrees 30 minutes; thence east by the said parallel to intersect the sea coast of the Gulf of Carpentaria, thence generally south-easterly by the said sea coast to intersect the meridian of east longitude 138 degrees; thence south by the said meridian to the point of commencement, and including all Northern Territory of Australia coastal islands south of parallel of south latitude 15 degrees 30 minutes.

Agricultural and Veterinary Chemicals (Control of Use) Act 2004

Directions of Use of Registered Veterinary Chemical Products by Non-Veterinarians

I, Daniel Gerard Whitfield-Jones the appointed Chemicals Coordinator under the *Agricultural and Veterinary Chemicals (Control of Use) Act 2004* (the **Act**), consider that in order to protect users (non-veterinarians) of a class of chemical product (Schedule 4 and 8 substances), that instructions by a veterinarian **must be in writing** in accordance with section 25(2)(a) of the *Agricultural and Veterinary Chemicals (Control of Use) Act 2004*.

For a class of veterinary chemical product that contains Schedule 4 and 8 substances, section 25(2)(b) is not available to non-veterinarians when considering the application of section 77 of the *Medicines, Poisons and Therapeutic Goods Act 2012*.

Failing to comply with this direction is an offence under section 87(2). This direction is a reviewable decision under the Act, the process for review is outlined in Part 11 of the Act.

Schedule 4 and 8 substances are listed under the Poisons Standard (SUSMP) managed by the Therapeutic Goods Administration (Commonwealth).
