Hot work means any construction, demolition, alteration, repair or maintenance work involving burning, cutting, welding, grinding, drilling or any other heat, flame or spark producing operation. If a contractor is undertaking the hot work on the vessel, then the contractor will apply for the hot work permit. A residual current device for portable equipment is mandatory.
