- (a) under section 6 of the *Cancer (Registration) Act 2009* (the **Act**) and with reference to section 44(1) of the *Interpretation Act 1978*, terminate the appointment of Xiaohua Zhang as Registrar; and

 - (ii) the person is able to perform the duties of the office and the circumstance, if any, specified opposite the person in the Schedule exists; and
