Revocation of Determination and Determination of Fees

I, Lia Emele Finocchiaro, Minister for Police:

- (a) under section 6(1) of the *Firearms Act 1997* (the **Act**) and with reference to section 43 of the *Interpretation Act 1978*, revoke all determinations of the fees payable under the Act that are in force; and
- (b) under section 6(1) of the Act, determine that the fee payable under the Act in relation to a matter described in the Schedule is the fee specified opposite the matter in the Schedule.
