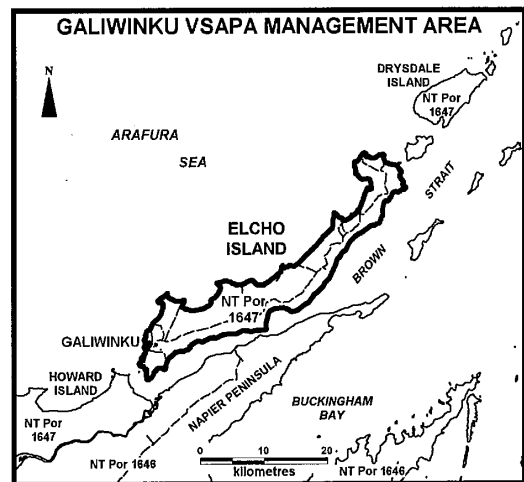

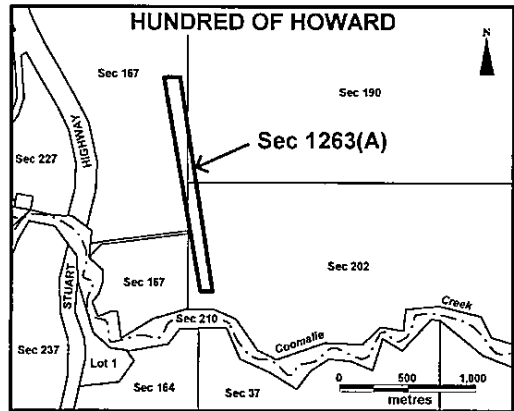

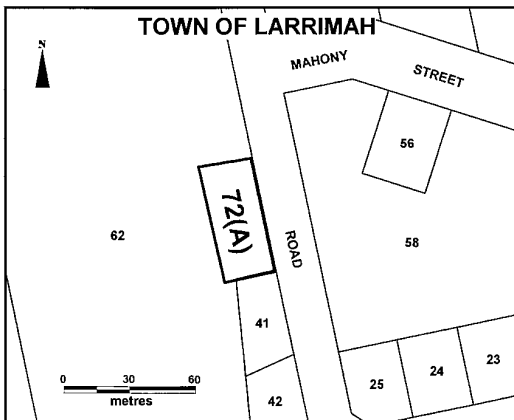

**APPROVAL OF ALCOHOL MISUSE INTERVENTION AND ALCOHOL INTERVENTION PROVIDERS**

I, DELIA PHOEBE LAWRIE, Minister for Justice and Attorney-General, under section 20 of the *Alcohol Reform (Prevention of Alcohol-related Crime and Substance Misuse) Act* and with reference to sections 8 and 42 of the *Interpretation Act*, approve:

- (a) the following alcohol misuse intervention that may be provided to persons given BAT notices under section 9(2) (a) of the *Alcohol Reform (Prevention of Alcohol-related Crime and Substance Misuse) Act*:
  - (i) assessment of drinking risk and other contributing factors related to drinking risk;
  - (ii) counselling and any other therapies the alcohol intervention provider considers appropriate; and
- (b) the following classes of persons who may provide the alcohol misuse intervention:
  - (i) medical practitioners;
  - (ii) persons who are registered under the Health Practitioner Regulation National Law to practise (other than as a student) in the nursing and midwifery profession as a nurse (a registered nurse);
  - (iii) persons who have a right of practice under the *Health Practitioners Act* in the category of health care practice of Aboriginal health work;
  - (iv) persons who are registered under the Health Practitioner Regulation National Law to practise (other than as a student) in the psychology profession and who work for an entity that employs a medical practitioner or registered nurse;

- (v) persons who are alcohol and other drug workers and who work for an entity that employs a medical practitioner or registered nurse.

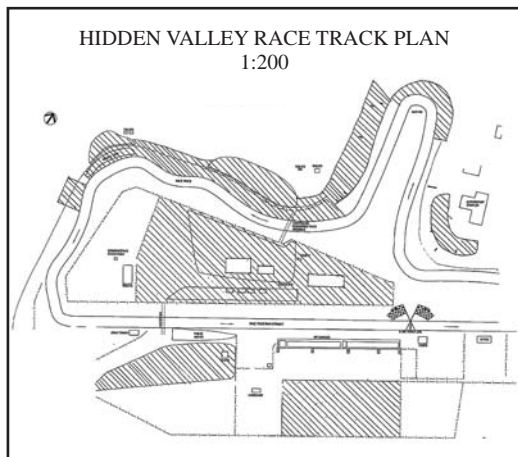
