1. Citation

This amendment to the NT Planning Scheme may be cited as Amendment No. 83.

2. Definition

In this amendment –


"amending map" means the map, signed by the Minister for Planning and Lands and marked "NT Planning Scheme Amendment No. 83", deposited in the office of the Department of Planning and Infrastructure, Darwin;

Amendment No. 65

"zoning map" means the zoning map within the meaning of the NT Planning Scheme.

3. Amendment of zoning map

The NT Planning Scheme is amended by amending the zoning map relating to Palmerston to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered LI, GI and CN, which is part Lot 9889 Town of Palmerston (Wishart Road Elrundie) and adjacent Crown land and part Section 70 Hundred of Bagot (McFarland Road Tivendale).

 - (i) part Lot 9889 Town of Palmerston and adjacent Crown land (Wishart Road Elrundie) from Zone DV (Development) to Zones LI (Light Industry) and GI (General Industry);
 - (ii) a small section of Lot 9889 Town of Palmerston (Wishart Road Elrundie) from Zone CN (Conservation) to Zone GI (General Industry);
 - (iii) two small sections of Crown land adjacent to Lot 9889 Town of Palmerston from Zone DV (Development) to Zone CN (Conservation); and
 - (iv) part section 70 Hundred of Bagot (McFarland Road Tivendale) from Zone DV (Development) to Zone LI (Light Industry); and

NT PLANNING SCHEME AMENDMENT

AMENDMENT No. 83

Reasons for Decision

The proximity of Lot 9889 Town of Palmerston (Wishart Road Elrundie) to the Palmerston residential areas makes it a more suitable location for light and general industry than the major strategic industries that are encouraged within Zone DV (Development). On this basis, I have approved the rezoning of Lot 9889 Town of Palmerston and adjacent Crown land from Zone DV (Development) to Zones LI (Light Industry) and GI (General Industry).

I have altered the submitted proposal in accordance with the revised plan submitted by the applicant. The change provides a buffer of Zone LI (Light Industry) adjacent to the Palmerston rural residential areas.

I have also decided to fix four anomalies in relation to zoning boundaries in the locality. Three relate to the location of the Zone CN (Conservation) boundary and the other relates to a small triangle of land within Section 70 Hundred of Bagot (McFarland Road Tivendale) zoned DV (Development) within an area zoned LI (Light Industry).

The Zone CN (Conservation) boundary has been adjusted to follow the cadastral boundary in three locations and the triangle of land has been zoned LI (Light Industry).
