Costs involved with assessments, including any required training, are not regulated by Government and may vary between endorsing bodies. The Director of Commercial Passenger (Road) Transport (the Director) collects the information on this form to determine whether or not persons are eligible to apply to be the holder of a CPVID Card in accordance with the provisions of the *Commercial Passenger (Road) Transport Act*.
