**Workers Rehabilitation and Compensation Advisory Council**  
**Expressions of Interest**

A vacancy has become available for membership to this Council.

The Attorney-General and Minister for Justice invites nominations from interested persons within the Northern Territory who:

- (a) have a wide range of experience across all major industry sectors in the Territory; and
- (b) are representatives of organisations representing employees or employers; and
- (c) has expertise in the rehabilitation of injured workers or the insurance industry

The Workers Compensation and Rehabilitation Advisory Council comprises of no more than ten members appointed by the Minister and a member constituting the Authority.

The Council has the following functions:

- (a) to keep the operation of this Act under review;
- (b) to make recommendations to the Minister on possible improvements to the administration of this Act, or the statutory scheme for the rehabilitation and compensation of injured workers in the Territory;
- (c) to carry out investigations, at the request of the Minister, into questions about the rehabilitation and compensation of injured workers and to report to the Minister on the results of the investigations;
- (d) to perform any other advisory functions relating to workers rehabilitation and compensation as the Minister directs.

An appointed member holds office for the period, not exceeding two years, specified in the appointment. Sitting fees are available to members.
