Water Act

Revocation of Declaration and Declaration of Daly Roper Beetaloo Water Control District

I, Lauren Jane Moss, Minister for Environment and Natural Resources:

- (a) under section 22 of the *Water Act* and with reference to section 43 of the *Interpretation Act*, revoke the declaration made by notice entitled "Declaration – Daly Roper Water Control District" dated 8 December 2008 and published in *Gazette* No. G50 of 17 December 2008; and
- (b) under section 22 of the *Water Act*, declare the part of the Territory specified in the Schedule to be a water control district for surface water and ground water management and allocate to the district the name Daly Roper Beetaloo Water Control District.

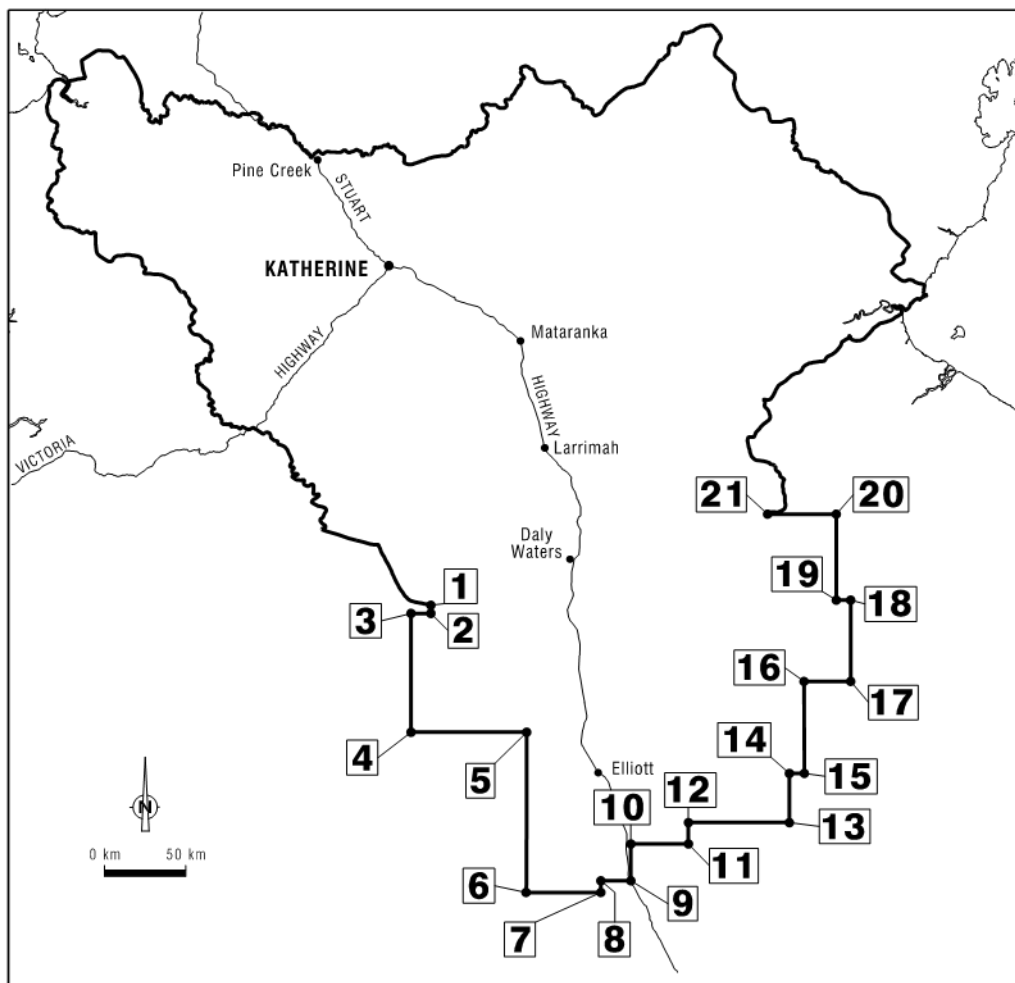

Schedule

All that area of land and the sedimentary basins below this area in the Territory bounded by the Australian Surface Water Management Areas (ASWMA) 2000 of the Daly and Roper catchments plus the area starting at a point on the southern boundary of the Daly River catchment and proceeding south and east then north to a point on the eastern boundary of the Roper River catchment as described in the table and shown bound by thick black lines on the map.

**Revocation of Declaration and
Declaration of Water Allocation Plan
Daly Roper Beetaloo Water Control District**

I, Lauren Jane Moss, Minister for Environment and Natural Resources:

- (a) under section 22B(1) of the *Water Act* and with reference to section 43 of the *Interpretation Act*, revoke the declaration made by notice entitled "Daly Roper Water Control District Revocation and Declaration of Water Allocation Plan" dated 6 April 2016 and published in *Gazette* No. S23 of 7 April 2016; and
- (b) under section 22B(1) of the *Water Act*, declare the Water Allocation Plan for the Tindall Limestone Aquifer, Katherine 2016 – 2019 to be a water allocation plan in respect of the Daly Roper Beetaloo Water Control District; and
- (c) under section 22B(2) of the Act, specify that the water allocation plan will remain in force until 19 August 2019.
