AMENDMENT TO NT PLANNING SCHEME

AMENDMENT No. 500

1. Citation

This amendment to the NT Planning Scheme may be cited as Amendment No. 500.

2. Definition

In this amendment –

"amending map" means the map, signed by the Minister for Infrastructure, Planning and Logistics and marked "NT Planning Scheme Amendment No. 500", deposited in the office of the Department of Infrastructure, Planning and Logistics, Darwin;

"zoning map" means the zoning map within the meaning of the NT Planning Scheme.

3. Amendment of Zoning Map

The NT Planning Scheme is amended by amending the zoning map relating to Alice Springs to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered PS which includes Lot 2522 (6) Managaji Road, Tennant Creek.

Reasons for Decision

NORTHERN TERRITORY PLANNING SCHEME
AMENDMENT No. 500

Lot 2522 (6) Managaji Road, Tennant Creek is suitable for rezoning from Zone SD (Single Dwelling Residential) to Zone PS (Public Open space), as it will facilitate the development and use of the site for a neighbourhood park and is generally reflective of the indicative zoning that was reflected in the plans endorsed as part of Development Permit DP14/0405.

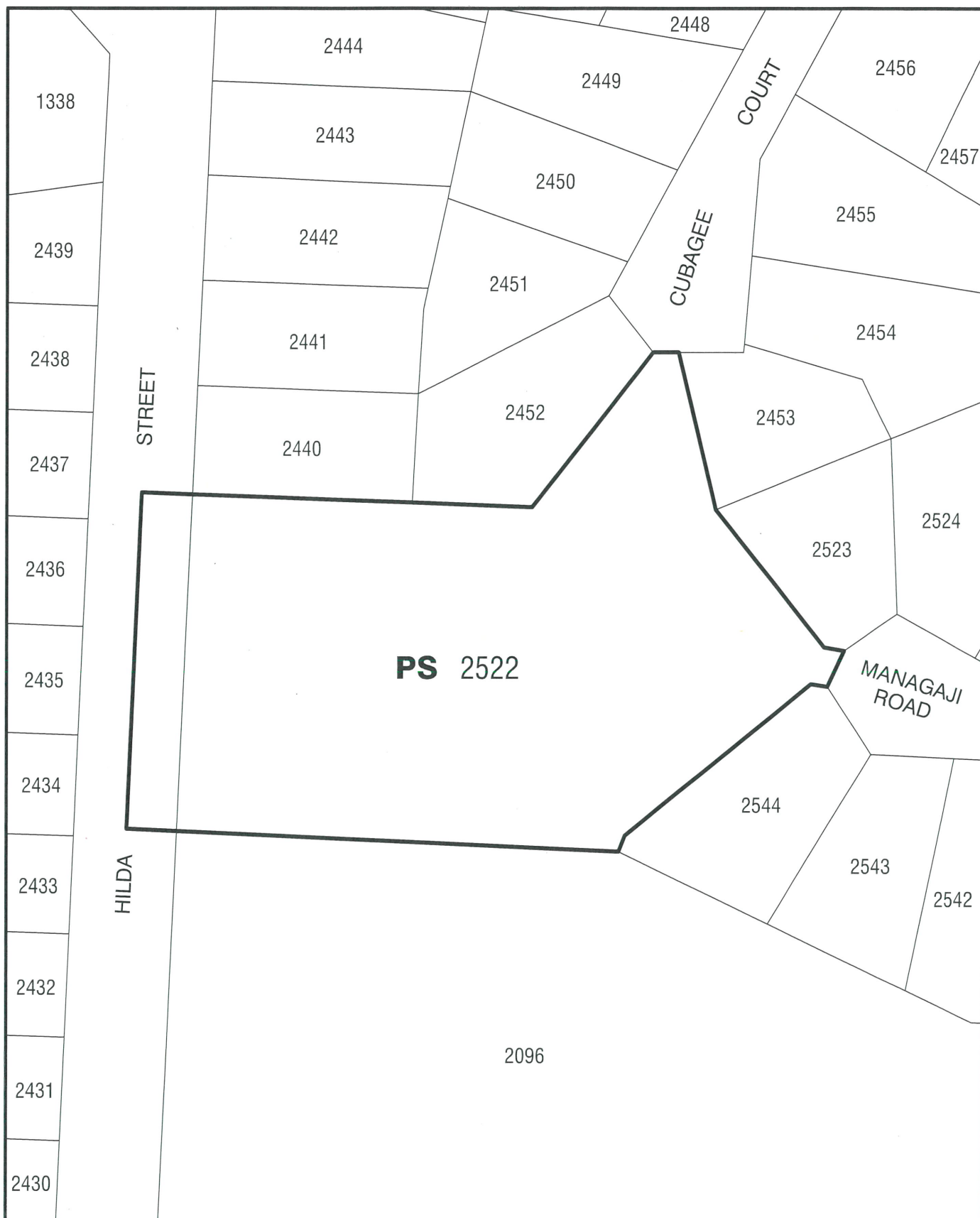
The proposed amendment is considered to be a normalisation process of amending the NT Planning Scheme, by introducing standard zones that better reflect the proposed land use to enable development and management of public open space in a manner that is consistent with the provisions of the NT Planning Scheme.
