Medicines, Poisons and Therapeutic Goods Act 2012

Bupa Wellness Declarations and Approvals

I, Hugh Crosbie Heggie, Chief Health Officer:

- (a) under section 252 of the *Medicines, Poisons and Therapeutic Goods Act 2012*, declare each health clinic specified in the Schedule, Part A, to be a place to which Part 2.6 of the Act applies; and
- (b) under section 254(1) of the Act, approve each Scheduled substance treatment protocol specified in the Schedule, Part B, for the following places:
 - (i) each health clinic specified in the Schedule, Part A;
 - (ii) the pharmacy known as 'Hibiscus Day and Night Pharmacy' located at Shop 4 Hibiscus Shopping Town, 8 Leanyer Drive, Leanyer NT; and
- (c) under section 250(1)(a) of the Act and with reference to section 42 of the *Interpretation Act 1978*, declare each nurse employed by Bupa Wellness Pty Limited ACN 145 612 951 (**Bupa**) and practising at a place mentioned in paragraph (b) to be an approved nurse to supply, administer to another person and possess the Schedule 4 substances specified in the Schedule, Part C, in accordance with each

Scheduled substance treatment protocol specified in the Schedule,
Part B, and subject to the condition specified in the Schedule, Part D.
