*Transport of Dangerous Goods by Road and Rail
(National Uniform Legislation) Act 2010*

Appointment of Officers

I, Melissa Jane Garde, the Acting Competent Authority:

- (a) under section 23(1) of the *Transport of Dangerous Goods by Road and Rail (National Uniform Legislation) Act 2010* and with reference to section 44 (1) of the *Interpretation Act 1978*, terminate all appointments of authorised officers in force immediately before the date of this instrument; and

- (iii) to reflect changes of address or other circumstances.
