- (a) declare that the maximum amount of damages a court may award for non-pecuniary loss, applicable for section 27(1) of the Act, is \$662 000; and
- (b) state that this declaration takes effect on 1 October 2019.

All that area of land and sea in Shoal Bay in the Darwin Region in the Northern Territory of Australia containing an area of 50 hectares or thereabouts and designated Northern Territory Portion 7495(A) and contained within a rectangle commencing at a point bearing 357 degrees 31 minutes and 2324.8 metres from the most western north-western corner of Section 3123, Hundred of Bagot, and thence by lines bearing 270 degrees for 550 metres, 360 degrees for 909.1 metres, 90 degrees for 550 metres and 180 degrees for 909.1 metres to the point of commencement.
