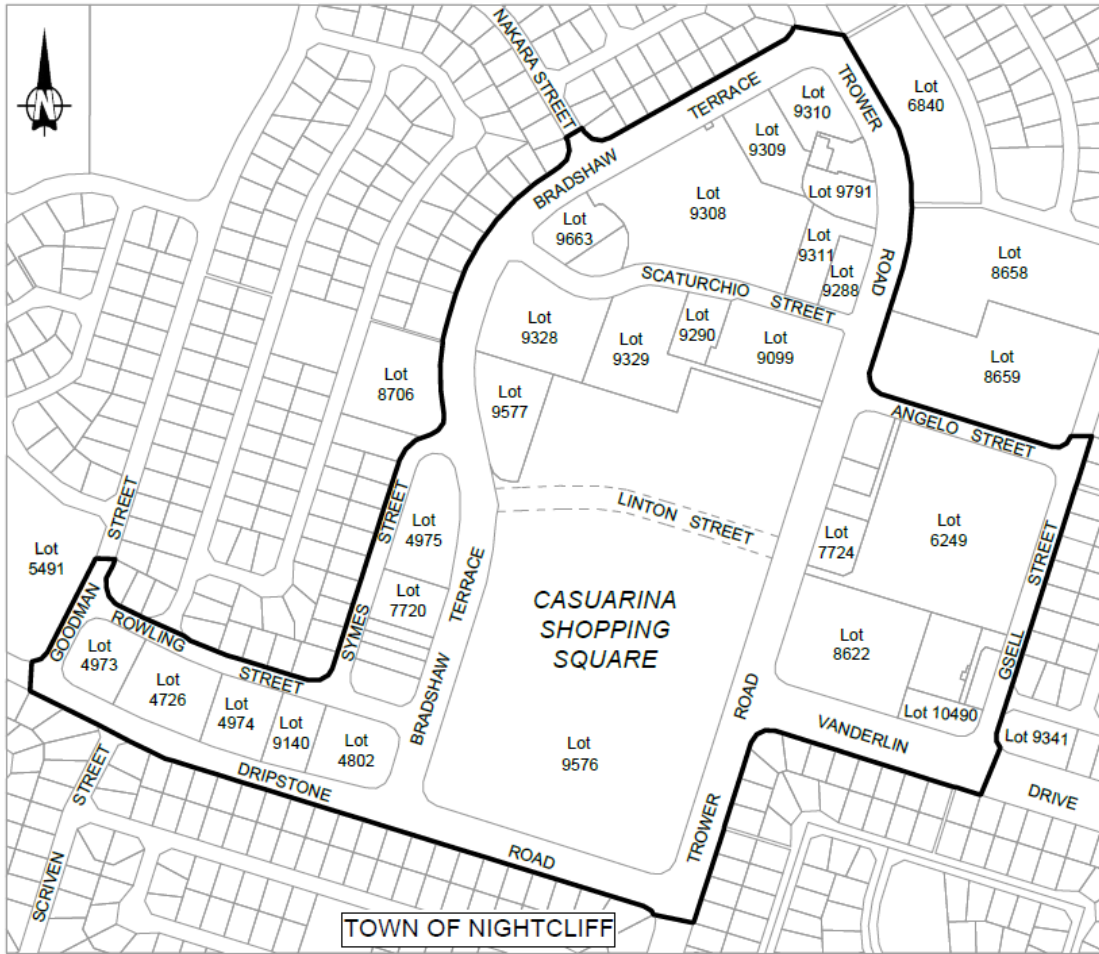
Declaration of High Risk Area: Casuarina Precinct

Electric Vehicle Number Plate Label Temporary Exemption
