## PRESCRIBED WARNING

This warning is to be read to the purchaser by an officer authorised by the Commissioner, or member of the Police Force of the Northern Territory who is witnessing this contract in accordance with the <u>Consumer Affairs and Fair Trading Act 1990</u> and the <u>Consumer Affairs and Fair Trading (Motor Vehicle Dealers)</u> Regulations 1992.
