### **Schedule**

#### **1 Definitions**

In this Schedule:

***affected land***, see section 5(1) of the *Petroleum Act 1984*.

***former Darwin Rural Water Control District*** means the part of the Territory declared to be a water control district by the instrument entitled 'Revocation of Declaration and Declaration of Darwin Rural Water Control

District' dated 17 May 1999 and published in *Gazette* No. G21 of 2 June 1999.

***parcel of land*** means the whole of the land the subject of a separate certificate as to title registered under the *Land Title Act 2000*.

***title area***, see section 8 of the *Mineral Titles Act 2010*.

## 2 Declaration

Subject to any requirements of a water allocation plan declared under section 22B of the *Water Act 1992*, Part 6, Division 4 of the Act does not apply to or in relation to any of the following bores located outside the former Darwin Rural Water Control District:

- (a) a bore on a parcel of land if:
  - (i) the bore is taking water from an aquifer underlying the parcel of land for any of the beneficial uses mentioned in section 4(3)(a) to (f) of the Act; and
  - (ii) the total volume of water taken from the aquifer from all bores on the parcel of land does not exceed 5 megalitres per year for those combined beneficial uses;
- (b) a bore on a title area if:
  - (i) the bore is taking water from an aquifer underlying the title area for the beneficial use mentioned in section (4)(3)(h) of the Act; and
  - (ii) the total volume of water taken from the aquifer from all bores on the title area does not exceed 5 megalitres per year for that beneficial use;
- (c) a bore on affected land if:
  - (i) the bore is taking water from an aquifer underlying the affected land for the beneficial use mentioned in section (4)(3)(i) of the Act; and
  - (ii) the total volume of water taken from the aquifer from all bores on the affected land does not exceed 5 megalitres per year for that beneficial use.

## **Revocation of Declaration and Declaration of Beneficial Uses and Objectives in Darwin Rural Adelaide River Water Control District**

I, Hugh Crosby Heggie, Administrator of the Northern Territory of Australia, acting with the advice of the Executive Council, with effect commencing on 1 July 2024:

- (a) under sections 22A(1) of the *Water Act 1992* (the **Act**) and with reference to section 43 of the *Interpretation Act 1978*, revoke the instrument entitled 'Declaration of Beneficial Uses Darwin Rural Water Control District' dated 11 June 2019 and published in *Gazette* No. G25 of 19 June 2019; and
- (b) under section 22A(1) of the Act, declare the beneficial uses of all surface water and groundwater located in the Darwin Rural Adelaide River Water Control District (the **District**) to be the following:
  - (i) agriculture;
  - (ii) aquaculture;
  - (iii) public water supply;
  - (iv) cultural;
  - (v) industry;
  - (vi) rural stock and domestic;
  - (vii) mining activity;
  - (viii) petroleum activity; and
- (c) under section 73(1) of the Act, declare that:
  - (i) the objectives described in Volume 1, Chapters 3, 4 and 5 of the Australian and New Zealand Guidelines for Fresh and Marine Water Quality (2000) (the **Guidelines**), published by the Australian and New Zealand Environment and Conservation Council and

Agricultural and Resource Management Council of Australia and New Zealand apply to water from all waterways located in the District; and

- (ii) the objectives described in Volume 1, Chapters 3, 4, 5 and 6 of the Guidelines apply to all groundwater located in the District.
