- 2 The BioSecure HACCP Scheme relates to plants and plant products produced by the nursery production industry.

Examples of the nursery production industry

Production nurseries, growing media production business and greenlife market businesses.

- 3 The criteria for appointing an accredited person for the BioSecure HACCP Scheme are the following:
  - (a) the person must be capable of performing the functions of an accredited person;
  - (b) the person must agree to comply with the conditions specified in section 42(1) of the Act;
  - (c) the person's nursery production business must hold BioSecure HACCP certification from Greenlife Industry Australia Limited ABN 59 634 584 017.

4 The requirements for the production of a plant or plant product of a type specified in the following Table for the making of an assurance certificate under the BioSecure HACCP Scheme are the requirements specified opposite.

#### **Revocation of Exemption and Exemption**

I, Christine Maree Connors, Chief Health Officer:

  - (iii) a food business that raises funds solely for community or charitable purposes which sells:
    - (A) food that is not potentially hazardous; or
    - (B) food that does not require prior preparation and is intended to be consumed immediately after cooking;
  - (iv) a food business, in furtherance of trade or business, that consists solely of serving:
    - (A) complimentary non-alcoholic beverages; or
    - (B) complimentary alcoholic beverages and are registered as a complimentary server of liquor under section 39 of the *Liquor Act 2019*;
  - (v) a food business which holds a licence issued under Part 3 of the Meat Industries Act 1996;
  - (vi) a food business that is operating temporarily in the Northern Territory as a mobile food business and either:
    - (A) holds a current registration as a food business or mobile food premises under the equivalent legislation of the *Food Act 2004* in another State or Territory; or
    - (B) has complied with section 86 of the Food Act 2001 (SA); or

(C) has complied with section 100 of the Food Act 2003 (NSW).
