## Notes for Guidance - Nominated Operator

Registered Owners of all heavy vehicles in the Northern Territory must nominate the name of a *Nominated Operator* as being responsible and accountable for the use of the vehicle on the general road network.

### Note 1 - Who is the Nominated Operator?

- ⇒ A person who has reached the age of eighteen (18) years.
- ⇒ Body Corporate

The *Nominated Operator* is not necessarily the legal owner. The recorded Registered Owner continues to be prima facie evidence of ownership.

### Note 2 - What is the Nominated Operator responsible for?

- ⇒ Cancellation of registration (the Nominated Operator will require written authority from the Registered Owner at the time of cancellation to receive refunds of registration, otherwise the refund will be forwarded to the Registered Owner).
- ⇒ Renewal of registration.
- ⇒ Presenting the vehicle for inspection.
- ⇒ Provision of sufficient information to prove garage address.
- ⇒ Change of garage address.
- ⇒ Change in residential address, or address for service of notices, such as renewal notices.
- ⇒ Vehicle write-off.
- ⇒ Change to a heavy vehicle that affects its description.
- ⇒ Change that would require payment for upgrade in registration due to a change in the vehicle's configuration.
- ⇒ Any traffic infringements detected by red light or speed camera where only the offending vehicle is identified. If the nominated operator was not the offending driver then he/she should declare the fact to avoid the infringement penalty and any applicable demerit points.

### Note 3 - One Nominated Operator

Only one person/Body Corporate can be recorded as being the *Nominated Operator*, and they must be nominated by the Registered Owner(s).

- ⇒ Where a vehicle is registered in joint names, only one (1) person can be nominated as the *Operator*, even though both parties may be the legal owners.
- ⇒ Where a vehicle is registered in a business name, only one (1) person can be nominated as the *Operator*, even though there may be more than one person in the business.
- ⇒ Where a vehicle is registered in a company name, the company is the registered owner, and they may nominate one (1) *Operator*.

### Note 4 - Privacy Statement

The Registrar of Motor Vehicles is required to collect information for Registrations, Licenses and Permits under section 92 of the NT *Motor Vehicles Act*.
