Dangerous Goods Regulations**APPROVAL OF PERIODS FOR
PURCHASING, POSSESSING AND THROWING, IGNITING
OR EXPLODING SHOPGOODS FIREWORKS**

I, DAVID WILLIAM TOLLNER, Minister for Business:

- (a) under regulation 139 of the *Dangerous Goods Regulations*, approve the period of time from 9 am to 9 pm on Tuesday 1 July 2014 as a period during which a person may purchase shopgoods fireworks; and
- (b) under regulation 140(1) of the Regulations and with reference to regulation 140A(1) of the Regulations:
- (i) approve the period of time from 9 am on Tuesday 1 July 2014 to 12 noon on Wednesday 2 July 2014 as a period during which a person may possess shopgoods fireworks, subject to the condition that this approval does not apply to the place specified in the Schedule; and
- (ii) approve the period of time from 6 pm to 11 pm on Tuesday 1 July 2014 as a period during which a person may throw, ignite or explode shopgoods fireworks, subject to the condition that this approval does not apply to the place specified in the Schedule.
