2. Definition

In this amendment -



"zoning map" means the zoning map within the meaning of the NT Planning Scheme.

3. Amendment of zoning map

The NT Planning Scheme is amended by amending the zoning map relating to Litchfield to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered RL and CN which is Sections 4920 - 4927, Hundred of Strangways and NT Portion 6600 Wheewall Road and adjacent Crown land, part Sections 1564 and 1565 Hundred of Ayers.

NT PLANNING SCHEME AMENDMENT

AMENDMENT No. 109

Reason for Decision

- The area described as Priority Environmental Management within Sections 4920 - 4927, Hundred of Strangways and NT Portion 6600 Wheewall Road and the adjacent Crown land to the west has been rezoned to Zone CN (Conservation) to conserve and protect the flora, fauna and character of the area.
- 2. The rezoning of the remainder of the site to Zone RL (Rural Living) will allow for subdivision to two hectares. As the intention is to service the development with reticulated water the development is unlikely to adversely affect the ground water resource.
- 3. Issues such as stormwater drainage and internal roads engineering; the proposed method of power and water supply and effluent disposal; and the erosion and sediment control methods during the construction phase of the development will be subject to additional public scrutiny during the assessment of the subdivision and development applications for the land by the Development Consent Authority.
