2. Definition


In this amendment -

"amending map" means the map, signed by the Minister for Lands and Planning and marked "NT Planning Scheme Amendment No. 118", deposited in the office of the Department of Lands and Planning, Darwin;

"zoning map" means the zoning map within the meaning of the NT Planning Scheme.

3. Amendment of zoning map

The NT Planning Scheme is amended by amending the zoning map relating to Darwin to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered CB which is part Lot 5619 Town of Darwin (proposed Lot 7670).

AMENDMENT No. 118

Reason for Decision

The rezoning site, part Lot 5619 (proposed Lot 7670) Town of Darwin is located adjacent to an existing commercial precinct on the McMinn Street service road. The land with a site area of approximately 792m² is behind Lot 7649 on McMinn Street.

The warehouse and hardstand on Lot 7649 extend onto the Crown land, Lot 5619. The NT Government has offered the owner of Lot 7649, JJH Development Pty Ltd, an Estate in Fee Simple over proposed Lot 7670 to formalise tenure over the building encroachment.

It is appropriate that proposed Lot 7670 be rezoned from Zone PS (Public Open Space) to Zone CB (Central Business) to formalise the zoning over the building encroachment.
