1. Citation

This amendment to the NT Planning Scheme may be cited as Amendment No. 39.

2. Definitions

In this amendment-


"amending map" means the map, signed by the Minister for Planning and Lands and marked "NT Planning Scheme Amendment No. 39", deposited in the office of the Department of Planning and Infrastructure, Darwin;

"zoning map" means the zoning map within the meaning of the NT Planning Scheme.

3. Amendment of zoning map

The NT Planning Scheme is amended by:

(a) amending the zoning map relating to Darwin to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered PS, which is Part Lot 5287 (proposed Lot 7627) Ross Smith Avenue, Town of Darwin.

NT PLANNING SCHEME AMENDMENT AMENDMENT No. 39

- Rezoning of proposed Lot 7627 Ross Smith Avenue, Town of Darwin from Zone MD (Multiple Dwelling Residential) to Zone PS (Public Open Space) of the Northern Territory Planning Scheme reflects the state of the land as intended through the Crown Lease Term, and subsequent development and subdivision of the old Arafura Bowls Club site as approved by the Development Consent Authority.
