**AMENDMENT OF NT PLANNING SCHEME**

**AMENDMENT No. 66**

**1. Citation**

This amendment to the NT Planning Scheme may be cited as Amendment No. 66.

**2. Definitions**

In this amendment--

"amending map" means the map, signed by the Minister for Planning and Lands and marked "NT Planning Scheme Amendment No. 66", deposited in the office of the Department of Planning and Infrastructure, Darwin;

"zoning map" means the zoning map within the meaning of the NT Planning Scheme.

**3. Amendment of zoning map**

The NT Planning Scheme is amended by:

- (a) amending the zoning map relating to Palmerston to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered SD and PS, which is Lots 9994 to 10011, Town of Palmerston.


