### REVOCAION OF DECLARATION AND DECLARATION OF DARWIN RURAL WATER CONTROL DISTRICT

I, TIMOTHY DENNEY BALDWIN, the Minister for Lands,  
Planning and Environment

- (a) in pursuance of section 22 of the *Water Act* and with reference to section 43 of the *Interpretation Act*, revoke the declaration of water districts notified in the *Gazette* No. S35 of 30 June 1992 in so far as it relates to the Darwin Rural Water Control District; and
- (b) in pursuance of section 22 of the *Water Act*, declare the part of the Territory described in the Schedule to be a water control district for surface water and groundwater management purposes and allocate to the water control district the name Darwin Rural Water Control District.

### SCHEDULE

#### DARWIN RURAL WATER CONTROL DISTRICT

All that area of land near Darwin in the Northern Territory of Australia bounded by lines described as follows:

Commencing at the most northern northwestern corner of Northern Territory Portion 3836, being a point on the boundary of the Shire of Litchfield as notified in Northern Territory Gazette No. S54 of 6 September 1985; thence generally southerly by western boundaries of the said portion to its southwestern corner; thence easterly by part of its southern boundary to the most eastern northeastern corner of Northern Territory Portion 3837; thence southerly by eastern boundaries of the said portion to its southeastern corner; thence westerly by a southern boundary of Northern Territory Portion 3837, across the Stuart Highway and again westerly by southern boundaries of Sections 200 and 243 Hundred of Howard, Northern Territory Portion 3837 and Section 2950 Hundred of Goyder to its southwestern corner; thence southerly and westerly by part of a western and a southern boundary of Northern Territory Portion 3516 to a southwestern corner of the said portion; thence westerly to the southeastern corner of Section 1111 Hundred of Goyder; thence northerly and westerly by the eastern and northern boundaries of the said section to its northwestern corner; thence northerly and generally westerly by a western and southern boundaries of Northern Territory Portion 3516 to an eastern boundary of Section 2965 Hundred of Goyder; thence westerly to a southwestern corner of the said section situated 20.12 metres northerly of the northeastern corner of Section 958; thence westerly and northerly by a southern and part of a western boundary of Section 2965 to the southeastern corner of Section 950; thence westerly and northerly by the southern and western boundaries of the said section to its northwestern corner; thence westerly across a road 20.12 metres wide to the southeastern corner of Section 876 and again westerly by the southern boundaries of the said section and Section 875 to its southwestern corner; thence westerly to the southeastern corner of Section 2138 Hundred of Finnis; thence northerly by the eastern boundary of the said section and its prolongation northerly to the southern boundary of Section 2751 Hundred of Hughes; thence easterly and northerly by parts of, the southern and eastern boundaries of the said section to the centreline of the River Charlotte; thence generally northwesterly by the centreline of the said river to the centre of its mouth at high water; thence generally northwesterly and northerly by the high water mark of Bynoe Harbour and Port Patterson to Charles Point; thence generally southeasterly, southerly and again southeasterly by the high water mark of Beagle Gulf, Port Darwin and Middle Arm to the centre of the mouth of Pioneer Creek, being a point on the boundary of the Shire of Litchfield; thence generally northeasterly, southeasterly and southwesterly by northwestern, northeastern and southeastern and southeastern boundaries of the said shire to the point of commencement.
