1. New Officers of the Firm must complete a NT Criminal History **Fingerprint** Check Application **for the purpose of Security**, which is to be submitted at SafeNT (Northern Territory police station). Additional charge applies.
Upon renewal of a licence, only a National Police History **Name** Check application **including spent convictions** is required.
2. A current Passport or Driver's Licence.
3. A completed disclosure, available in the 'Disclosures' section above.
4. A completed and signed unattested declaration, available in the 'Unattested Declaration' section above.
5. It shall be a condition of all licences that the licensee shall comply with the approved Code of Practice together with any other conditions prescribed in relation to such a licence.
