DARWIN NORTHERN SUBURBS LIQUOR ACORD

Aim

The Darwin Northern Suburbs Liquor Accord (DNSLA) is a voluntary agreement by licensee's and other stakeholders to take actions that aim to improve safety and amenity in the Northern Suburbs community by preventing and reducing anti-social behaviour and alcohol related violence.

The Darwin Northern Suburbs Liquor Accord will apply to the area in Attachment A - (Police boundary map to be provided)

Members of the Accord

Members of the DNSLA comprise representatives from participating licensed premises within the Northern Suburbs of Darwin, industry peak bodies, NT Police, City of Darwin, Licensing NT and other key stakeholders.

Initial members are set out in Schedule One. Additional members may be added and will be set out in an Addendum as appropriate.

Objectives

- Reduce alcohol related anti-social and violent behaviour in and around licensed premises, businesses and residential areas.
- Support and promote Responsible Service of Alcohol practices.
- Support and promote safety, security and amenity around business premises in the Northern Suburbs
- Reduce the impact of displacement brought about by the implementation of anti-social measures.
- Support cross cultural learning and awareness raising activities.
- Meet regularly to achieve the objectives of the Accord and meet the needs of the signatories.

DARWIN NORTHERN SUBURBS LIQUOR ACORD

Accord KPI's

- The key performance indicators for measuring the effectiveness of the Accord each year are;
- A demonstrated reduction in alcohol related crime and anti-social behaviour associated with take-away liquor consumed in the Northern Suburbs.
- Measurable commitment to provide appropriate cultural training and refresher courses beyond the minimum requirements of RSA qualifications for staff of licensed venues.
- Active participation of licensed venues, NT Police, local authorities, and Licensing NT.

Strategies

- The Accord endeavours to encourage licensees to develop management practices and approaches to ensure there is a level of consistency across the Northern Suburbs, with respect to;
- Supporting a Code of Practice, when implemented, to assist in the responsible sale, provision, promotion and consumption of takeaway alcohol.
- Promote and support Government legislation and initiatives that target anti-social behaviour, alcohol related violence and problem drinking. E.g. Sober-Bob, 2klm law.
- Work with Accord partners as specified below to try and address issues of displacement
- Harm minimisation strategies subject to the approval of Licensing NT and other relevant authorities.
- Accord strategies specific to the Darwin Northern Suburbs Liquor Accord as set out in Schedule TWO of this document.

DARWIN NORTHERN SUBURBS LIQUOR ACORD

Meetings

Members of the DNSLA will meet quarterly as a minimum, or as necessary by a majority vote, to review and monitor impacts of the strategies. The Accord will review continuation of each strategy contained within Schedule TWO with the view to maintaining the Accord.

Communications

Upon successful financial support, the Accord will develop a package of community friendly, inclusive communication tools including media releases, posters, point of sale information and a front of premises sticker to demonstrate Accord membership.

Relationship with Authorities

Licensees will closely liaise and collaborate with the Accord Partners and Licensing NT to improve public safety and community amenity in and around licensed venues.

SCHEDULE TWO

The following strategies, as agreed to by Accord members, will continue indefinitely upon approval of Licensing NT. Regular review of these strategies and their effectiveness will occur every three months.

Licensees agree to apply the following measures to manage and control certain alcoholic products, with the intention of reducing alcohol fuelled anti-social behaviours.

	STRATEGY...
1.	Venues will not sell bulk wine products greater than 2Ltrs
2.	(Removed June 2019)
3.	(Removed June 2019)
4.	No promotions for bulk wine products (Casks).
5.	Recording & reporting of suspicious sales, behaviour and Secondary supply to Licensing NT & NT Police
6.	Counter Sales: No Shirt, No Shoes - No service.
7.	Prominent display of Accord membership promotional material
8.	No Credit (book-up)
9.	Provision of CPTED advice to all members (Crime Prevention Through Environmental Design)
10.	Lobby Government to introduce other measures to reduce alcohol related anti-social behaviours. This may include minimum pricing or other initiatives as determined by this Accord.
