**Revocation, Declarations and Approval**

I, Hugh Crosbie Heggie, Chief Health Officer:

- (a) under sections 250, 252 and 254(1) of the *Medicines, Poisons and Therapeutic Goods Act* and with reference to section 43 of the *Interpretation Act*, revoke the declarations and approvals made by:
- (i) the instrument entitled "Northern Territory School Health Services" dated 26 February 2015 and published in *Gazette* No. S18 of 2 March 2015; and
  - (ii) the instrument entitled "Northern Territory School Health Services" dated 28 April 2014 and published in *Gazette* No. S22 of 30 April 2014; and
- (b) under section 252 of the *Medicines, Poisons and Therapeutic Goods Act*, declare each health centre or clinic specified in the Schedule, Part A, to be a place to which Part 2.6 of the Act applies; and
- (c) under section 254(1) of the Act, approve each Scheduled substance treatment protocol specified in the Schedule, Part B, for each health centre or clinic specified in the Schedule, Part A; and
- (d) under section 250(1)(a) of the Act, declare each nurse or midwife practising at a health centre or clinic specified in the Schedule, Part A, to be an approved nurse or approved midwife (as appropriate) to supply, administer to another person and possess the Schedule 4 substances specified in the Schedule, Part C, in accordance with each Scheduled substance treatment protocol specified in the Schedule, Part B; and
- (e) under section 250(1)(b) of the Act, declare each Aboriginal and Torres Strait Islander health practitioner practising at a health centre specified in the Schedule, Part A, to be an approved ATSI health practitioner to supply, administer to another person and possess the Schedule 4 substances specified in the Schedule, Part C, in accordance with each Scheduled substance treatment protocol specified in the Schedule, Part B.


