Notice of Variation to the Electricity Retail Supply Code

In accordance with section 24(7) of the *Utilities Commission Act 2000*, the Commission gives notice that it has made an administrative variation to the Electricity Retail Supply Code (the Code), which will commence on 1 December 2019.

The Code was made in 2011 and last varied on 18 January 2016. The Code has been amended to reflect changes in the Northern Territory electricity supply industry, including to associated legislation, such as the adoption of the National Electricity Law and Rules, modified for the Territory. Further, the Code has been amended to introduce new protections for electricity customers that require life support equipment.

**Declaration of Water Allocation Plan

(National Uniform Legislation) Act 2010*

Appointment of Officers

Interim Development Control Order (No. 26)

1. This order applies to all land in Zone MD (Multiple Dwelling Residential) in Major Remote Towns listed below ("the land").

2. Construction of dwellings that are permitted only by virtue of this order must have commenced prior to the expiry of this IDCO.

3. A multiple dwelling is permitted without consent in a town listed in Paragraph 1 of this IDCO.
4. Notwithstanding paragraph 3, a multiple dwelling permitted by this IDCO is to comply with the following requirements:
 - (a) the dwelling density is 1 per 450m² of site area;
 - (b) fencing to private open space is a minimum height of 1.2 meters;
 - (c) significant shade trees are to be retained on the site and one shade tree is to be provided per private open space; and
 - (d) any other relevant provisions of the NT Planning Scheme as they relate to multiple dwellings.
