

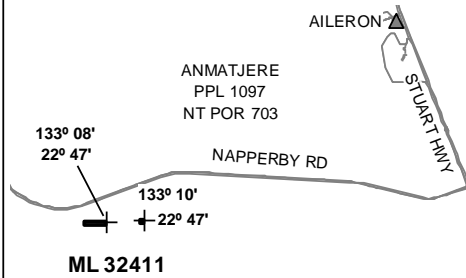
NOTICE OF PROPOSED GRANT OF MINERAL LEASE

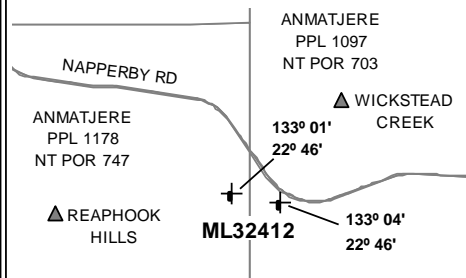

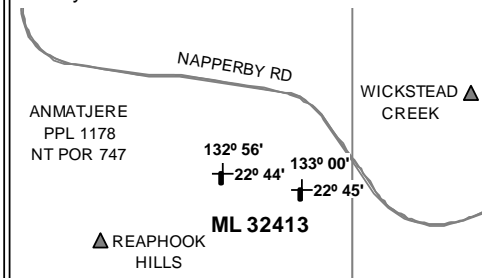

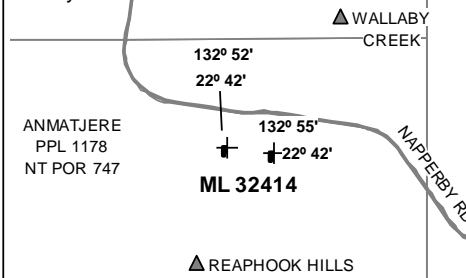

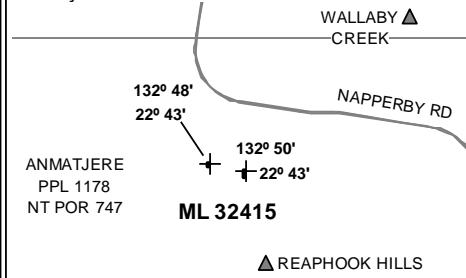

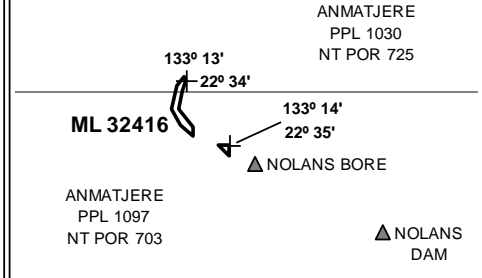
