Weapons Control Act 2001

Exemption

I, Hugh Crosbie Heggie, Administrator of the Northern Territory of Australia, acting with the advice of the Executive Council, under section 12(5) of the *Weapons Control Act 2001* and with reference to section 12(7) of the Act, exempt each class of persons described in the Schedule from the application of section 6 of the *Weapons Control Act 2001* to the extent and subject to any conditions specified for the class, in relation to an article designed or adapted to discharge oleoresin capsicum spray (the ***prohibited weapon***).

Schedule

- 1 The public sector employees in the Agency responsible for administering the *Public Transport (Passenger Safety) Act 2008* (the **Agency**) who are permitted to acquire supplies under the *Procurement Act 1995* are exempt from the application of section 6(c) of the *Weapons Control Act 2001* to the extent it prohibits the purchase of the prohibited weapon.
 - 2 The public sector employees in the Agency who provide administrative support to the class of persons mentioned in clause 1 are exempt from the application of section 6(e) of the *Weapons Control Act 2001* to the extent it prohibits the possession of the prohibited weapon, subject to the condition that the public sector employees are only permitted to possess the prohibited weapon for the purpose of collecting it from the place of purchase or place in the Territory to which it is delivered by a common carrier and delivering it into the possession of a transit officer appointed under section 6 of the *Public Transport (Passenger Safety) Act 2008*.
 - 3 Contractors engaged by the Agency to dispose of the prohibited weapons are exempt from the application of section 6(e) of the *Weapons Control Act 2001* to the extent it prohibits the possession of the prohibited weapon, subject to the condition that the contractors are only permitted to possess a prohibited weapon for the purpose of safely disposing it.

Revocation and Declaration of Datjala Work Camp, Nhulunbuy as Correctional Centre

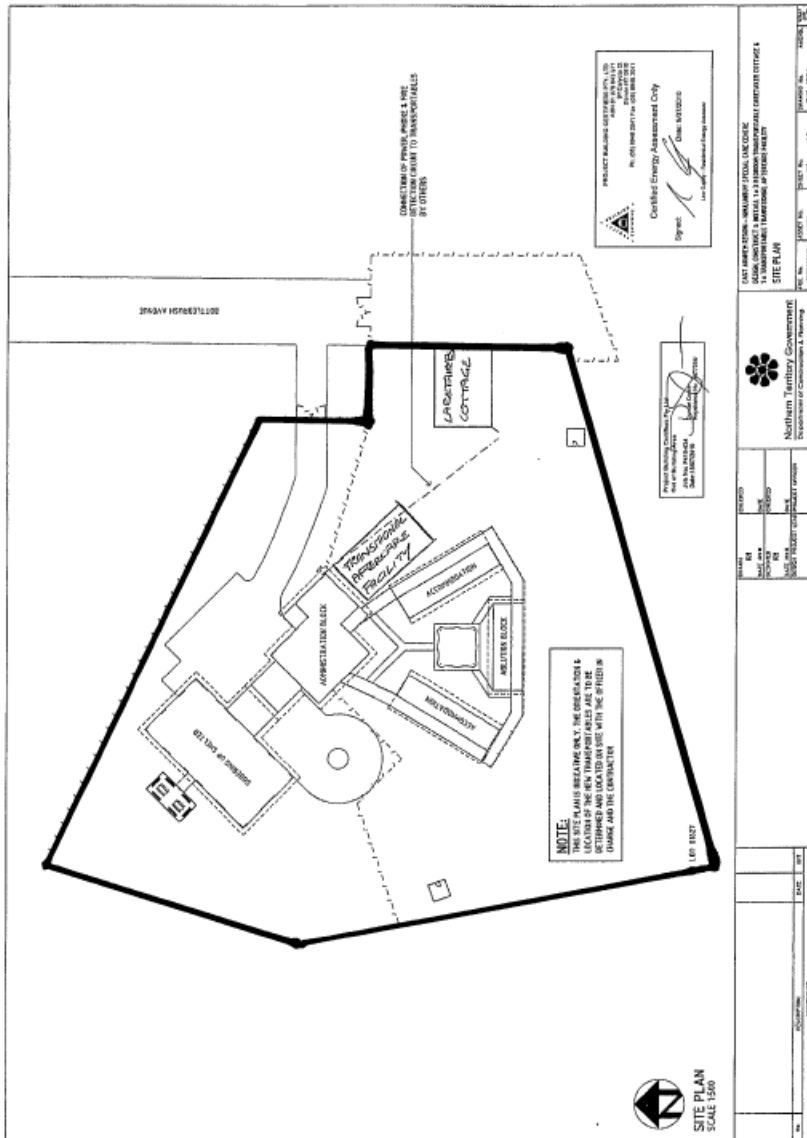
I, Chanston James Paech, Attorney-General and Minister for Justice:

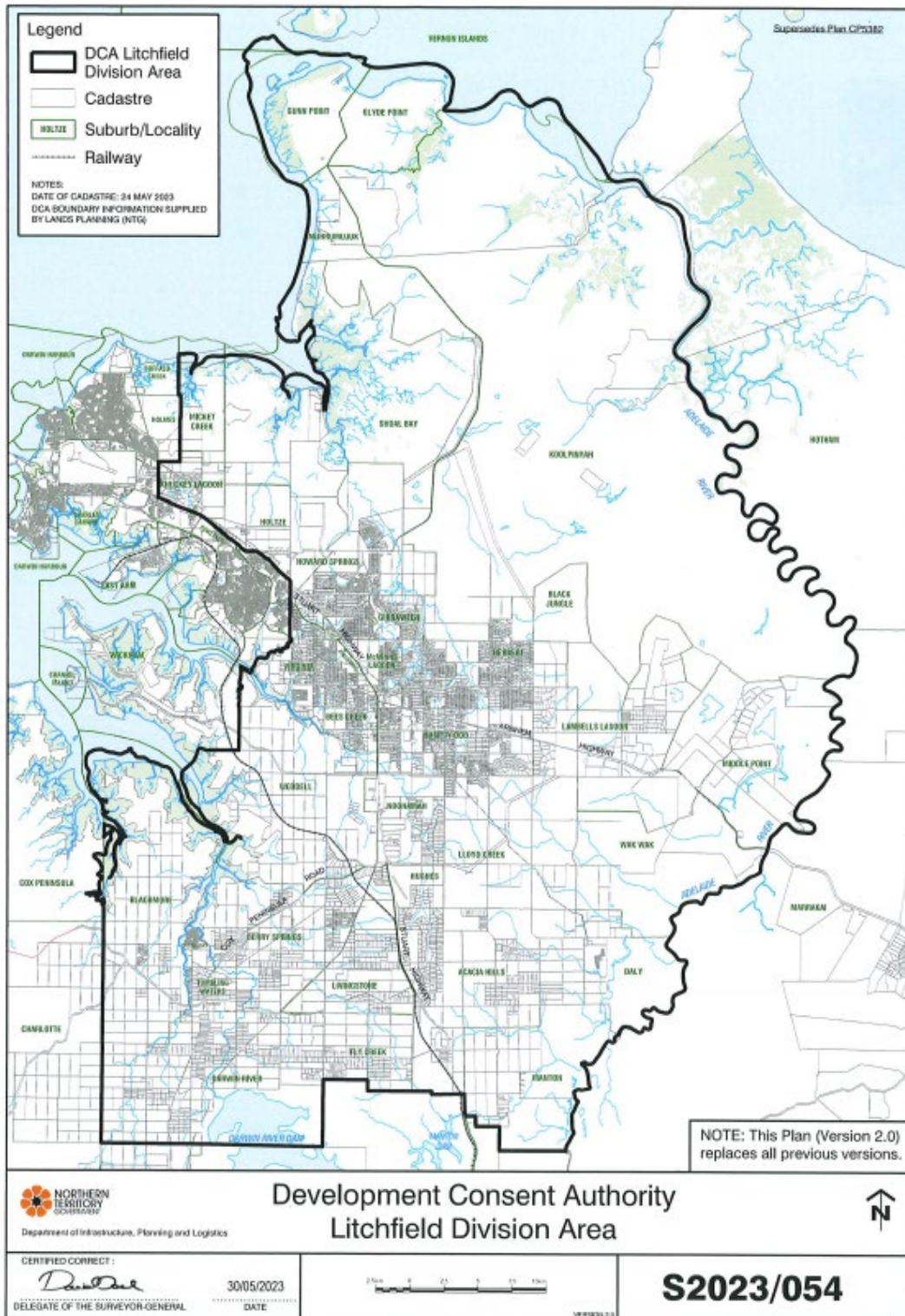
