Re: McArthur River Mine - Independent Monitor Annual Environmental Performance Audit Report 2023

The Department welcomes the opportunity to respond to the Independent Monitor's findings presented in their fourth Annual Environmental Performance Audit Report 2023 (Audit Report) for the period 1 May 2022 through to 30 April 2023.

Key findings of the Independent Monitor's Audit Report with respect to evaluation of the Department include:

- continued regulatory attention on the key environmental risk areas having translated into improved performance in the audit period
- the monitoring and management actions of the operator and regulator have continued to protect the health of the McArthur River from mine related impacts
- no significant environmental issues requiring urgent investigation or additional regulatory attention being identified at McArthur River Mine or Bing Bong Loading Facility
- achievement of an overall compliance of 97% against 149 active conditions in Authorisation 0059 a 1% improvement on 2022 when assessed against 81 less active conditions
- maintaining a compliance score of 98% with respect to implementation of NT EPA recommendations requiring action by the Department

I am pleased with the Department's performance as the regulator of McArthur River Mine in achieving a 97% overall compliance score. However, I acknowledge that while demonstrating strong compliance in relation to conditions of Authorisation 0059 and NT EPA recommendations, there remains room for improvement which the Department can implement to maintain its already strong focus on environmental outcomes.

I am heartened that the small number of "part compliance" determinations made do not represent a risk to the environment with minimal consequence to the environmental performance of the mine and the health of the McArthur River. The part compliances, where a small number of elements of the Authorisation condition (17 of the 149 active conditions audited) and NT EPA recommendations (11 of the 116 elements) were not satisfied, relate to administrative tasks.

The Department's response to the identified Opportunities for Improvement (OFIs) arising from these part compliances are presented in **Attachment A** against the three aspects audited by the Independent Monitor: Authorisation 0059 (Table 4-3), NT EPA recommendations (Table 4-6) and Regulatory Approach (Table 4-8). The detail in the attached tables comprise an extract from the Annual Environmental Performance Audit Report 2023 against which the Department provides its specific response.

I am pleased by the Department's response to OFIs previously identified by the Independent Monitor. Action to address past OFIs has supported continuous improvement and has contributed to the consistently high compliance scores attained by MRM.

I would like to acknowledge the high level of compliance maintained by my Department, considering the increased number of conditions of Authorisation and NT EPA recommendations becoming active and requiring action over the last four years. This trend is evident in the following figures.



In addition to the environmental performance audit conducted annually, the Independent Monitor undertook a number of targeted audits focusing on key environmental management systems approved for implementation at McArthur River Mine.

These systems required under the *Mining Management Act 2001* are essential to effective environmental management by MRM to achieve the overarching objective of protecting the health of the McArthur River from mine-related impacts. The management systems reviewed included those relating to air quality and surface water, adaptive management and the Independent Certifying Engineer. In relation to each of these I offer the following comments that validate the approval of the relevant documents under the *Mining Management Act 2001*:

- The Independent Monitor concluded MRM's air quality management meets best practice requirements and is effective in minimising the risk of potential air emissions-related impacts from sulphur dioxide (SO₂) and dust related impacts on the Mine and surrounding areas. Importantly, implementation of the Air Quality Management Plan and waste rock management practices consistent with the approved MMP has eliminated the historical waste rock combustion issue that was the primary cause of the SO₂ issues
- The Independent Monitor concluded the surface water management activities undertaken in accordance with the approved Water Management Plan were effective in avoiding uncontrolled

releases of contaminated water from onsite water storages. The surface water plan requires ongoing annual water balance assessments that inform water inventory management in order to meet the overarching objective of protecting the health of the McArthur River from mine-related impacts

- The Independent Monitor acknowledged the significant improvements made to the approved Adaptive Management Plan as a result of refinement over various iterations to provide greater clarity regarding processes on site for environmental management, monitoring and performance reporting. The incorporation of results from studies undertaken to address information gaps and monitoring programs has facilitated continuous improvement to the Adaptive Management Plan
- The Independent Monitor concluded oversight activities undertaken by the Independent Certifying Engineer are important to giving assurance to the broader community that the engineered structures built on the Mine site are built according to plans designed to meet performance criteria that will protect the health of the McArthur River from mine-related impacts. I take this opportunity to advise that improvements to processes around documentation identified by the Independent Monitor, that would enhance the role of the Independent Certifying Engineer, have been addressed in Authorisation 0059 varied in May 2023.

Overall, I am pleased with the performance of my Department as the regulator for McArthur River Mine that has resulted in the Independent Monitor finding "Continued focus on the effective management and monitoring of key environmental risk areas by the Operator and DITT has resulted in improved performance during the audit period. This has involved ongoing implementation of management actions to avoid or reduce environmental risk."

The achievement of regulatory compliance scores of 97% or higher by both MRM and the Department can be attributed to the strong commitment of both parties to work to develop and implement practical, risk and evidence based conditions to achieve positive environmental outcomes.

The Department remains committed to effective regulation of all mining activities under the *Mining Management Act 2001* and will continue to work with MRM to protect the health of the McArthur River from mine-related impacts.
