

Motor Vehicles Act 1949

Exemption

I, Cindy-Lee McDonald, Registrar of Motor Vehicles, under section 135 of the *Motor Vehicles Act 1949* and with reference to section 5A of the Act, exempt all trailers with an aggregate trailer mass of 750 kg or less (a **trailer**) from the provisions of the Act specified in the Schedule, subject to the conditions specified in the Schedule.

Schedule

1 In this Schedule:

declared compensation contribution means the compensation contribution declared under section 47 of the Act that is payable under section 45(1) of the Act for the grant or renewal of registration of a trailer.

prescribed fee means the prescribed fee that is payable under section 13(1) of the Act for the grant or renewal of registration of a trailer.

2 Subject to clause 3, a trailer is exempt from the application of the 12-month period for which registration of a motor vehicle may be in force under section 103(1) of the Act.

3 A trailer is only exempt under clause 2 if each of the following conditions has been satisfied in respect of the trailer:

(a) an application has been made for the grant or renewal of registration of the trailer under section 92 of the Act after the date of this instrument;

- (b) in the application, the applicant has requested that the registration of the trailer be granted or renewed for one of the following periods (an **extended registration period**) instead of the period specified in section 103(1) of the Act:
 - (i) 2 years;
 - (ii) 3 years;
 - (c) in considering the application, the Registrar is satisfied the registration of the trailer should, unless cancelled or suspended under the Act, be in force for the extended registration period requested by the applicant;
 - (d) the applicant has made payment of an amount equivalent to:
 - (i) if the extended registration period requested is 2 years – the prescribed fee multiplied by 2; or
 - (ii) if the extended registration period requested is 3 years – the prescribed fee multiplied by 3;
 - (e) the applicant has made payment of an amount equivalent to:
 - (i) if the extended registration period requested is 2 years – the declared compensation contribution multiplied by 2; or
 - (ii) if the extended registration period requested is 3 years – the declared compensation contribution multiplied by 3.
- 4 If the conditions in clause 3 are satisfied, the registration of the exempt trailer is, unless cancelled or suspended under the Act, to be in force for the extended registration period referred to in clause 3(b) instead of the period specified in section 103(1) of the Act.
