*Weeds Management Act 2001*

## **Declared Weed: Siam Weed (*Chromolaena odorata*)**

I, Joshua Roland Burgoyne, Minister for Lands, Planning and Environment:

- (a) under section 7(1) of the *Weeds Management Act 2001* (the **Act**) and with reference to section 43 of the *Interpretation Act 1978*, revoke the declaration of the plant Siam weed (*Chromolaena odorata*) as a declared weed made by the instrument entitled 'Declared Weeds' dated 11 December 2006 and published in *Gazette* No. G51 of 20 December 2006; and
- (b) under section 7(1) of the Act and with reference to section 7(4)(b) of the Act:
  - (i) declare the plant Siam weed (*Chromolaena odorata*) (**Siam weed**) to be a declared weed for the purposes of preventing the plant entering into, and managing the plant in, the Territory; and
  - (ii) classify Siam weed as a Class B weed for the purpose of preventing the growing and spreading of the plant.
