Roads in Gunn, Town of Palmerston

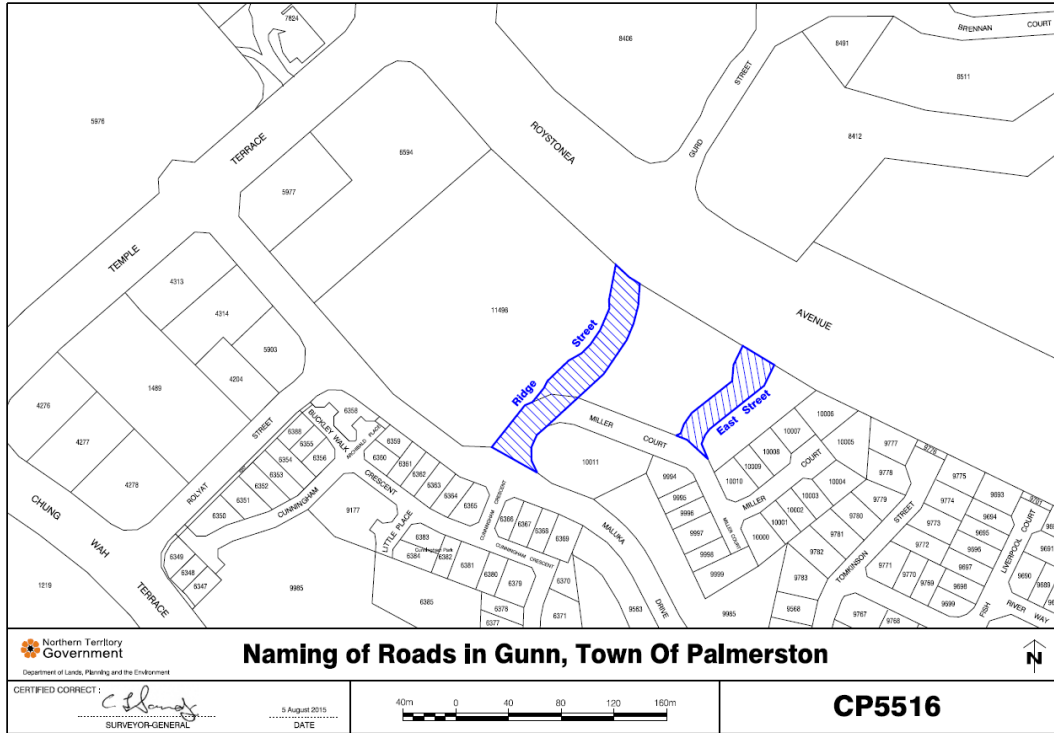
I, David William Tollner, Minister for Lands and Planning, under section 11D(1) of the *Place Names Act*, give notice that:

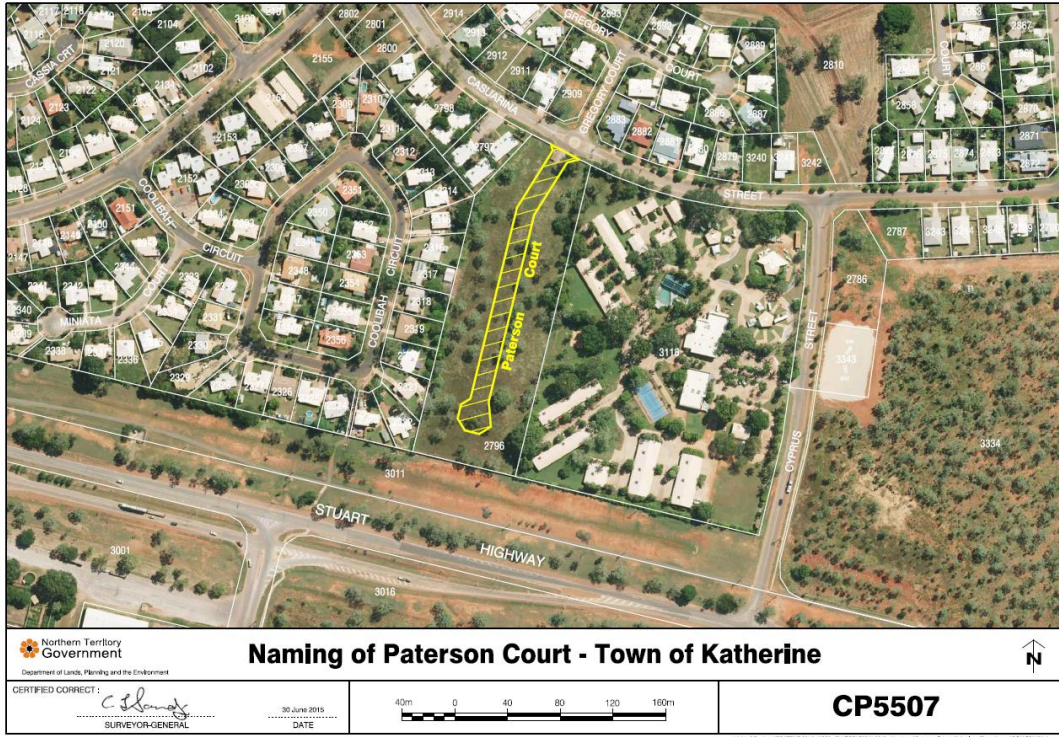
