

**Territory Parks and Wildlife Conservation Act****REDECLARATION OF PARKS AND RESERVES**

I, KARL RIO HAMPTON, Minister for Parks and Wildlife, under section 24(2) of the *Territory Parks and Wildlife Conservation Act*:

- (a) revoke each declaration under section 12 of the *Act* specified in Schedule 1; and
- (b) declare each of the areas of land specified in Schedule 2, to be a park; and
- (c) declare that a right, title or interest held by the Territory in respect of the land, or a part of the land (including any subsoil), within the park declared by paragraph (b) does not, on the declaration of the park vest in the Conservation Land Corporation.

2. All that parcel of land known as Simpson's Gap National Park Extension near Alice Springs in the Northern Territory of Australia containing an area of 1,921 hectares more or less being the whole of Northern Territory Portion 6629 more particularly delineated on Survey Plans S2005/27A to D inclusive lodged with the Surveyor General, Darwin.

All that parcel of land known as Serpentine Gorge Nature Park near Alice Springs in the Northern Territory of Australia containing an area of 518 hectares more or less being the whole of Northern Territory Portion 779 more particularly delineated on Survey Plan OP1333 lodged with the Surveyor General, Darwin.

All that parcel of land known as Glen Helen Gorge Nature Park near Alice Springs in the Northern Territory of Australia containing an area of 386 hectares more or less being the whole of Northern Territory Portion 831 more particularly delineated on Survey Plan A322 lodged with the Surveyor General, Darwin.

All that parcel of land known as Ormiston Gorge and Pound Nature Park near Alice Springs in the Northern Territory of Australia containing an area of 4,656 hectares more or less being the whole of Northern Territory Portion 910 more particularly delineated on Survey Plan OP1331 lodged with the Surveyor General, Darwin.
