*Motor Vehicles Act and Traffic Act*

Exemption from *Motor Vehicles Act* and *Motor Vehicles (Standards) Regulations*

I, Paul Nathan Rajan, the Registrar of Motor Vehicles, pursuant to section 135 of the *Motor Vehicles Act* and section 43B of the *Traffic Act*, hereby exempt segways (two-wheeled self-balancing, battery-powered personal transportation devices with a single axle, a platform for the feet and an upright post surmounted by handles) while used by police officers in the course of their duties from the registration, motor accident compensation contributions, vehicle standards and driver licensing requirements of the *Motor Vehicles Act*, *Traffic Act* and the *Motor Vehicles (Standards) Regulations*, subject to the following conditions:

1. This exemption only applies to the use of segways by police officers in the course of their duties as police officers.
2. A police officer using a segway on a footpath or shared path must—
  - (a) keep to the left of the footpath or shared path unless it is impracticable to do so; and
  - (b) give way to pedestrians on the footpath or shared path.
3. A police officer using a segway on a footpath or shared path must keep to the left of any oncoming bicycle rider or other segway user on the path.
4. A police officer using a segway must wear a bicycle helmet approved for the purposes of Australian Road Rule 256 and securely fitted and fastened on the user's head.
5. A police segway being used at a speed over 12km/h must display a blue or red flashing light or sound an alarm unless it is reasonable in the circumstances not to display the light or sound the alarm.
6. A police officer must not use a segway unless the segway has a bell, horn or similar warning device in working order.

7. A police officer must not use a segway at night, or in hazardous weather conditions causing reduced visibility, unless the officer, or the segway, displays—
- (a) a flashing or steady white light that is clearly visible for at least 200m from the front of the segway; and
  - (b) a flashing or steady red light that is clearly visible for at least 200m from the rear of the segway.

This exemption is separate to and does not supersede the general segway exemption made by me on 29 May 2014
