## 1. Citation

This amendment to the NT Planning Scheme may be cited as Amendment No. 201

## 2. Definition


In this amendment -

"amending map" means the map, signed by the Minister for Lands and Planning and marked "NT Planning Scheme Amendment No. 201", deposited in the office of the Department of Lands and Planning, Darwin;

"zoning map" means the zoning map within the meaning of the NT Planning Scheme.

## 3. Amendment of Zoning Map

The NT Planning Scheme is amended by amending the zoning map relating to Palmerston to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered M (Main Road) which is near Lots 10974 and 4236 Town of Palmerston (Johnston).

## NT PLANNING SCHEME AMENDMENT

#### **AMENDMENT No. 201**

#### **Reasons for Decision**

The Stuart Highway road reserve was recently widened near Lots 10974 and 4236 Town of Palmerston. The areas of land that are now part of the Stuart Highway were zoned FD (Future Development) and should be zoned M (Main Road) since Northern Territory highways are included in Zone M (Main Road).

The NT Planning Scheme ensures that the use or development of land in Zone M (Main Road) does not prejudice traffic safety or the amenity of the main road.

I am satisfied that the amendment is not so significant to warrant exhibition and I have amended the NT Planning Scheme to rezone those parts of the Stuart Highway near Lots 10974 and 4236 Town of Palmerston.
