

# Owner's permission to use the run

To accompany application for three-letter brand or transfer of brand or request to change the run

**Notes** If you are NOT the registered owner of the land as registered with the Lands Titles Office, then you are required to have the registered Owners give permission to use their property/land/run by completing this form. All registered owners of the land must sign this form – see below.

If application is for use on Aboriginal Land Trust (ALT), the Applicant/s must submit appropriate paperwork –

- Application for 3 Letter Brand (register a new 3ltr brand) or Application for Transfer of Brand or Request to Change the Run (move an existing brand); AND
- Together with - evidence that the appropriate agreement with NLC or CLC has been signed off stating the terms of the agreement (parties involved, period of agreement and any conditions / restrictions).

And

The NLC or CLC must submit appropriate paperwork –

- **Owner's Permission to Use Run** form to be completed by NLC or CLC authorised Pastoral Projects Co-ordinator or Rural Enterprise Officer etc: together with:
  - NLC or CLC Legal Advisor/Solicitor to attach letter confirming the terms of the agreement (S19 parties involved, period of agreement and conditions/restrictions) that the Land Council consents and has no objections to this application being approved by Registrar and processed as per *Livestock Act* and Regulations; and
  - NLC or CLC to supply a map of the area in which the Brand is to be registered for use on.
