

# Commercial Passenger Vehicles Information Bulletin – CPV34

## Assessing a Vehicle as a Commercial Passenger Vehicle

### Introduction

The purpose of this Information Bulletin is to provide a consistent and transparent process to the customer and Department of Logistics and Infrastructure staff when assessing the suitability of a vehicle type for use in a commercial passenger vehicle (CPV) category.

A vehicle will be assessed when processing an application to use any modified and / or imported vehicle as a CPV.

### Background

The Director Commercial Passenger (Road) Transport (the Director) approves the vehicle types for use as a CPV in the Northern Territory.

A factory standard / unmodified production vehicle that is fitted with an Australian compliance plate may be approved for use as a CPV provided the vehicle:

- complies with the requirements and in-service vehicle maintenance standards for the vehicle category (as applicable); and
- passes the CPV standards inspection.

With the deregulation of the Courtesy Vehicle Category, businesses that provide a courtesy service will not be required to have their vehicles assessed as a CPV. All vehicles that are used to provide a courtesy service will be subject to normal inspection regimes. Please refer to the Motor Vehicle Registry website for further information.

Rideshare vehicles will only require a roadworthy vehicle inspection from an authorised vehicle inspector as well as meeting the conditions as set out in the Ridesharing In-service Vehicle Maintenance Standards.

Passenger seating capacity for vehicles will be determined by the number of seats as indicated on the vehicle's compliance plate (not including the driver).

A Single Uniform Type Inspection (SUTI) will be required for any:

- modified or imported vehicle; or
- vehicle without an Australian Compliance Plate.

In any of these cases, the passenger seating will be individually assessed.

## In-Service Vehicle Maintenance Standards

The principal purpose of in-service vehicle maintenance standards is to provide the CPV industry with a set of guidelines for determining the minimum acceptable standards for vehicles.

These guidelines include, but are not limited to safety and vehicle technical standards. These guidelines are applicable to vehicles when being assessed for first registration and to vehicles that are already in-service.
