**Notice of Acquisition**

I, Eva Dina Lawler, the Minister for Infrastructure, Planning and Logistics, in pursuance of section 43 of the *Lands Acquisition Act*, declare that the land described in Schedule 1, which, as a result of an application under Part 8 of the *Pastoral Land Act*, is being excised as an Aboriginal Community Living Area from the pastoral lease described in Schedule 2, is acquired by the Northern Territory and that an estate in fee simple in that land is, by virtue of section 46(1A) of the *Lands Acquisition Act*, granted to the Doojum Aboriginal Corporation, the association formed or approved pursuant to Part 8 of the *Pastoral Land Act* to take that land.
