 - i. such greyhounds shall be properly muzzled and on a leash; and
 - ii. one person shall not exercise more than four greyhounds at any one time; and
 - iii. no greyhound shall be exercised in any public park without the consent of the authority in control of that park; and; and
- e) I agree to open the kennels for inspection at any time by an authorised officer of the Commission and I agree to notify the Commission forthwith of any change (temporary or otherwise) in the address of my kennels or residence; and
- f) At the date of this application, the greyhounds mentioned below are registered in my name as owner or lessee for which owner's registration certificates are required; and
- g) All statements and information contained in this application are true and correct to the best of my knowledge by virtue of the *Oaths*, *Affidavits and Declarations Act 2010*; and
