Notice of Variation to the Electricity Retail Supply Code

In accordance with section 24(7) of the *Utilities Commission Act 2000*, the Commission gives notice that it has made a variation to the Electricity Retail Supply Code, which will commence on 8 February 2025.

The Electricity Retail Supply Code has been amended to incorporate an amended retailer of last resort scheme that is consistent with the framework established by the *Electricity Reform Act 2000* and the *Electricity Reform (Administration) Regulations 2000*. The Electricity Retail Supply Code has also been amended to include a new provision which allows the Commission to issue an exemption from the obligation to comply with one or more provisions of the Electricity Retail Supply Code.
