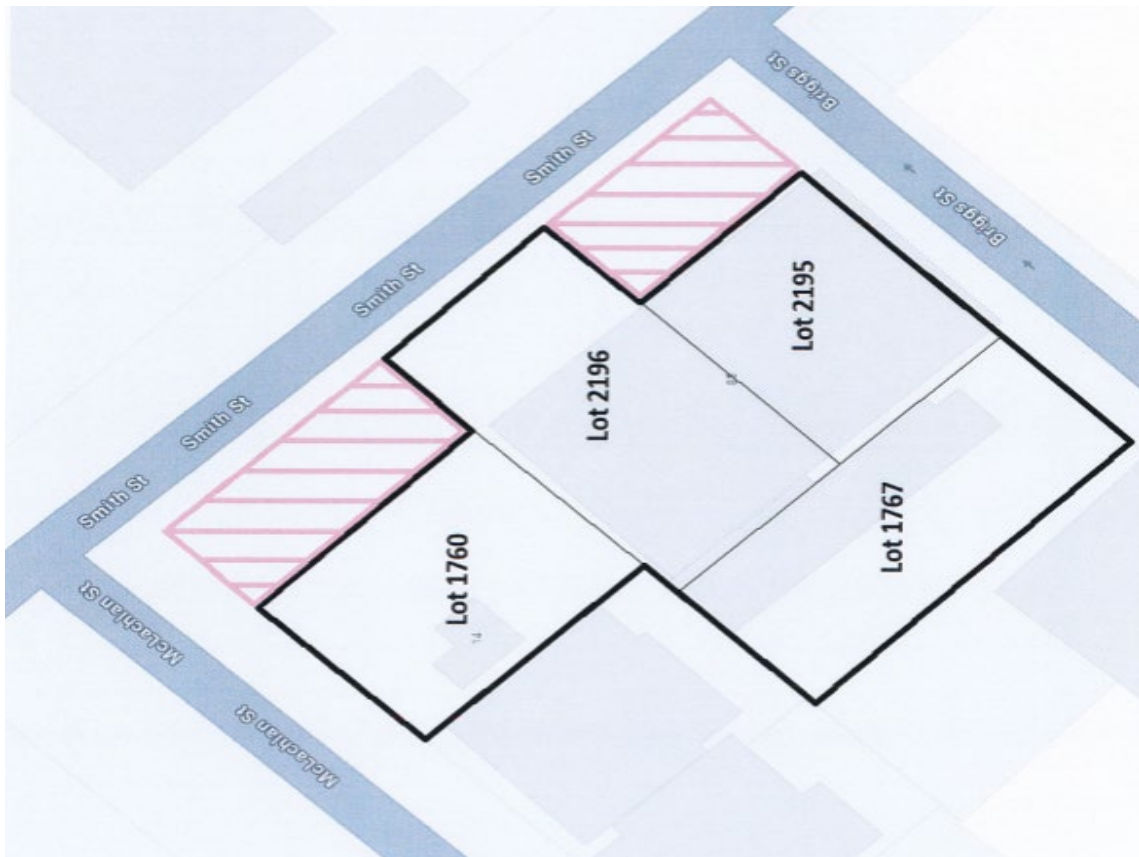
Order to Close Road
