SCHEDULE OF NOTES

- 1. This form can be used by the registered proprietor, within the meaning of section 4 of the Land Title Act, 2000 of the estate of the dominant land having the benefit of a covenant before the date the 20 year period referred to subsection 174 (1)(b) of the Law of Property Act 2000 expires. It cannot be used for covenants made in favour of the Commonwealth, the Territory or a prescribed authority for defence or aviation purposes, Covenants made for a prescribed purpose or Covenants in gross. Section 174 of the Law of Property Act 2000 only applies to Covenants made after the commencement of the Act (1 December 2000).
- 2. This form may be lodged in duplicate. The original must be typed or completed in ink or biro. The duplicate may be a copy of the original but the signatures of all parties and their witnesses must be original and signed in ink or biro. Alterations to information entered on the form should be crossed out (nor erased or obliterated by painting over) and initialled by the parties.
- 3. If there is insufficient space in any panel use the space below or an annexure sheet (Form 95).
- 4. The number and the date of extension of the covenant to be extended must be entered here. The duplicate covenant does not need to be produced for notation.
- 5. Volume and Folio references must be given together with complete parcel description of the land burdened by the covenant.

- 7. Volume and Folio references must be given together with complete parcel description of the land receiving the benefit of the covenant. If a certificate as to title has been issued it must be produced.

- 9. Persons who may witness this document are a Commissioner for Oaths, a member of the Legislative Assembly, a legal practitioner within the meaning of the Legal Profession Act 2006, a person holding office under the Supreme Court Act 1979, the Justices of the Peace Act 1991, the Local Court Act 2015 or the Registration Act 1927, a member of the Police Force, a person licensed as a conveyancing agent or real estate agent under the Agents Licensing Act 1979, a Notary Public and any other person approved by the Registrar-General.

A witness to an instrument executed by an individual must first:

- take reasonable steps to ensure that the individual is the person entitled to sign the instrument;
- have the individual execute the document in the presence of the witness;
- not be a party to the instrument; and
- if witnessing more than one signature, clearly state that he/she has witnessed more than one signature. (ie I have witnessed the two signatures appearing above).

After signing, witnesses must legibly write, type or stamp their names and contact address or telephone number below their signature.

For a corporation, an instrument must be executed in a way permitted by law or sealed with the corporation's seal in accordance with the Law of Property Act 2000, Section 48.

For witnessing of instruments executed outside the Northern Territory refer to Schedule 1 of the Land Title Act 2000 and the Registrar-General's Directions.
