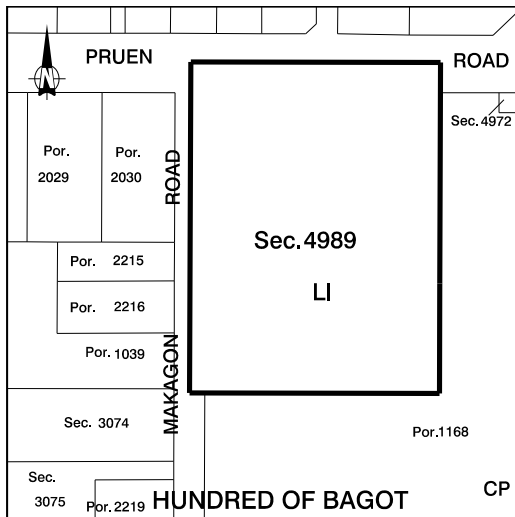

### Livestock Act

#### DECLARED AREA MOVEMENT RESTRICTIONS CATTLE TICKS (RHIPICEPHALUS MICROPLUS)

I, BRIAN LESLIE RADUNZ, Chief Inspector:

- (a) under section 59(1) of the *Livestock Act* and with reference to section 43 of the *Interpretation Act*, revoke the instrument entitled "Declared area movement restrictions cattle ticks (*Rhipicephalus microplus*)" dated 23 September 2010 and published in *Gazette* No. G40 of 6 October 2010, as amended by instrument dated 9 August 2011 and published in *Gazette* No. G36 of 7 September 2011 ; and
- (b) under section 59(1) of the *Livestock Act*, restrict the movement of livestock as set out in the Schedule.

### SCHEDULE

#### 1 Definitions

In this Schedule:

**approved program** means a property cattle tick management program approved in writing by the Chief Inspector.

**non-assessed property** means a property in the Control Zone where cattle ticks are suspected to occur, where surveillance has not been completed.

**Cattle Ticks Zones Declaration** means a *Gazette* notice made under section 58 of the *Act*, declaring the Territory, or specified areas of the Territory, to be a type of area or zone for the control of cattle ticks (*Rhipicephalus microplus*), as in force from time to time.

**certified solution** means a solution of which a sample has been chemically analysed by a laboratory approved by the Chief Inspector and certified by the laboratory to be a sample of a registered acaricide of a registered strength.

**Control Zone** means the area declared as such under the Cattle Ticks Zones Declaration.

**Free Zone** means the area declared as such under the Cattle Ticks Zones Declaration.

**at risk (high) property** means a property in the Control Zone where cattle ticks are not known to occur, and that has, within the previous 12 months, been assessed by the Chief Inspector and determined as being at high risk of cattle ticks occurring on the property.

**at risk (low) property** means a property in the Control Zone where ticks are not known to occur, and that has, within the previous 12 months, been assessed by the Chief Inspector and determined as being at low risk of cattle ticks occurring on the property.

**infected property** means a property in the Control Zone where cattle ticks are known to occur, and that has, within the previous 12 months, been assessed by the Chief Inspector and determined as having cattle ticks occurring on the property.

**Infected Zone** means the area declared as such under the Cattle Ticks Zones Declaration.

**registered** means registered by the Australian Pesticides and Veterinary Medicines Authority established by the *Agricultural and Veterinary Chemicals (Administration) Act 1992* (Cth).

**restricted livestock** means cattle, buffalo, horses, camels, llamas, alpaca, goats, sheep and deer.

#### 2 Livestock unloaded taken to start new movement

If restricted livestock being moved from one place to another is unloaded before reaching its destination, the restrictions imposed by this declaration apply separately to:

- (a) the movement from the starting place to the place of unloading; and
- (b) the movement from the place of unloading to the destination.

#### 3 Requirement for inspection, treatment and movement permit

(1) If restricted livestock in the Infected Zone is to be moved into or through the Free Zone or Control Zone, the owner of the livestock must ensure that the movement does not start unless:

- (a) the livestock meets the requirement of:
  - (i) a clean inspection; and
  - (ii) Level 1 treatment; and
- (b) a declared area movement permit has been granted for the movement.

(2) Subclause (1) does not apply if:

- (a) the livestock is to be moved from the Infected Zone, through the Control Zone (without stopping), into the Infected Zone; or
- (b) the movement is carried out in accordance with an approved program.

(3) If:

- (a) restricted livestock in the Control Zone is to be moved from a property of a kind specified in Table 1, column 1; and
- (b) the movement is of a kind described in Table 1, column 2, the owner of the livestock must ensure that the movement does not start unless:
- (c) the clean inspection and treatment requirements specified in Table 1, columns 3 and 4 in respect of that movement have been met; and
- (d) a declared area movement permit for the has been granted for the movement.

#### 4 Clean inspection

- (1) A requirement for a clean inspection is met if an inspector, having inspected the livestock, declares it to be free of visible ticks or free of ticks containing bodily fluids.
- (2) The inspection must be carried out:
  - (a) on the day on which the required treatment is carried out, or any earlier day approved by an inspector; and
  - (b) before the required treatment is carried out.

#### 5 Treatment

- (1) A requirement for Level 1 treatment is met if the livestock is treated in accordance with the requirements set out in Table 2.
- (2) A requirement for Level 2 treatment is met if the livestock is treated in accordance with the requirements set out in Table 3.

- (3) All Level 1 and Level 2 treatments must be carried out under the supervision of, and in the manner approved by, an inspector.
- (4) A requirement for plunge dip or spray dip treatment is met if the livestock is:
  - (a) for a plunge dip - fully immersed in a certified solution that was certified:
    - (i) at an export yard within the previous 30 days; or
    - (ii) at other yards - within the previous 60 days.
  - (b) for a spray dip - thoroughly sprayed with a solution approved by an inspector.
- (5) A requirement for macrocyclic lactone treatment is met if the livestock is treated with a registered macrocyclic lactone in accordance with the instructions of the manufacturer.
