*Food Act*

Revocation & Exemption

I Steven Jaye Skov, Chief Health Officer, under section 32(1)(b) of the *Food Act* and with reference to section 43 of the *Interpretation Act*,

- a) revoke instrument of exemption dated 24 June 2004, of Government Gazette No G.29 of 21 July 2004, reference 2/29; and
- b) exempt the following classes of businesses from the application of Part 7 of the *Food Act* namely;
  - 1) persons who hold licences under Part 2 of the *Water Supply and Sewerage Services Act*;
  - 2) food businesses that;
    - i. raise funds solely for community or charitable purposes; and
    - ii. which sell;
      1. food that is not potentially hazardous; or
      2. food that is intended to be consumed immediately after cooking;
- c) commercial businesses that serve;
  - 1) non-alcoholic complimentary beverages;
  - 2) pre-packaged, not potentially hazardous, ready to eat snacks;for the purpose of customer comfort.

**Note:**

Under Standard 3.2.2 of the *Food Standards Code* “potentially hazardous food” means “food that has to be kept at certain temperatures to minimise the growth of any pathogenic microorganisms that may be present in the food or to prevent the formation of toxins in the food.”
