AMENDMENT No. 68

1. Citation

This amendment to the NT Planning Scheme may be cited as Amendment No. 68.

2. Definitions

In this amendment -

"amending map" means the map, signed by the Minister for Planning and Lands and marked "NT Planning Scheme Amendment No. 68", deposited in the office of the Department of Planning and Infrastructure, Darwin;

"zoning map" means the zoning map within the meaning of the NT Planning Scheme.

3. Amendment of zoning map

The NT Planning Scheme is amended by amending the zoning map with respect of the area of land shown on the amending map bounded by a thick black line and lettered "SC", which is Portion 1827 (660) and Section 4298 (658), Stuart Highway, Hundred of Bagot
