
"zoning map" means the zoning map within the meaning of the NT Planning Scheme.


#### 3. Amendment of Zoning Map

The NT Planning Scheme is amended by revising the zoning map relating to Galiwinku to the extent of its inconsistency with the amending map in respect of the area of land shown on the amending map bounded by a thick black line and lettered C which is part NT Portion 1647 (Townsite of Galiwinku).

#### 4. Revision of Clause 14.6.20 Galiwinku Area Plan

Delete the Galiwinku Area Plan and replace with a new area plan to reflect the revised zoning.

#### **Reasons for Decision**

# NORTHERN TERRITORY PLANNING SCHEME AMENDMENT No. 406

Part NT Portion 1647 Townsite of Galiwinku is suitable for rezoning from Zone CP (Community Purposes) to Zone C (Commercial).

Specifically, this rezoning is suitable because:

- the proposal is supported by key stakeholders including the traditional owners of Galiwinku;
- a rezoning to facilitate a commercial precinct adjacent to the new residential subdivision will increase development options within walking distance of new housing and help to cater for population growth in the area; and
- an appropriate area for future community facilities is retained in Zone CP (Community Purpose).

Alterations to the Galiwinku Area Plan will ensure that the area plan is consistent with the amended Zoning Map.

I have decided to approve this amendment without public exhibition as significant consultation has been undertaken reflecting strong support for the establishment of a supermarket and commercial precinct at the proposed site, and the proposal is consistent with the reasons for decision originally given for the introduction of the Galiwinku Area Plan and Zoning Map.
