## Associated with the sale of NT properties with plant material

The Department of Industry, Tourism and Trade (DITT) receives requests for due diligence relating to current notices, orders and restrictions for plant material diseases/pests on properties under relevant legislation. With respect to plant material, the Chief Plant Health Offer (CPHO) advises:

- Departmental officers are able to provide information on orders or notices issued or proposed to be issued under the *Plant Health Act* 2008.
- Departmental officers are able to provide information on reports of notifiable pest or disease reports of plant material under the *Plant Health Act 2008*.
- Departmental officers are unable to provide other information except under a subpoena or freedom of information (FOI) request.
