Reasons for Decision

NORTHERN TERRITORY PLANNING SCHEME AMENDMENT No. 453

Inclusion of the Darwin Mid Suburbs Area Plan as a Policy Document to the NT Planning Scheme

Alterations have been made to the Darwin Mid Suburbs Area Plan in response to comments received during the period of exhibition and matters outlined by the Reporting Body. These alterations are summarised below.

- A minor change to section 3.1 (Residential Areas) Concept C (Residential
 areas affected by Riverine Flooding and Primary Storm Surge from
 Rapid Creek) to outline that any rezoning of parcels subject to the concept
 will not be considered unless compliance with the objectives of the concept
 is demonstrated. This change does not alter the intent of the concept;
 rather enforces the demonstration of the concept's objectives at the
 rezoning stage.
- Additional requirements within section 3.3 (Industrial and Service Commercial Areas) Concept B (Extension of Service Commercial Type Development) requiring consideration of the impact of development on essential services and transport infrastructure, and requiring a master plan to guide development to ensure any proposed development is in line with the objectives of the concept. The incorporation of the subject requirements will ensure that any future development is supported by investigations to ensure development impacts are minimised and the timely delivery of infrastructure occurs.
- Amendments to sections 3.2 (Activity Centres and Commercial Areas) and 3.4 (Social Infrastructure) broaden the requirements for social services and community facilities through redevelopment of the John Stokes Square precinct. This change is considered an improvement as it allows for the consideration of a broader range of community based uses in this location.
- Additional requirements included at section 3.5 (Movement and Transport) to acknowledge future changes to intersections of the arterial road network as demand arises, and to provide guidance around potential flood mitigation works on Bagot Road. These requirements were requested by the Department of Transport as the authority responsible for the arterial road networks.

- Alterations to requirements included at Section 3.5 (Movement and Transport) to acknowledge the existing pedestrian and cyclist network within the Mid Suburbs, and allow for a range of approaches to improve pedestrian and cyclist connections throughout the area. These changes were requested by the Department of Transport as the authority responsible for the arterial road networks.
- Clarification added to section 3.5 (Movement and Transport)
 acknowledging the conceptual nature of all guidance included within the
 Movement and Transport section of the Area Plan, and that further detailed
 planning and design is required before the implementation of final traffic
 solutions outlined by the plan. Final planning and design should also be
 accompanied by detailed community consultation.

The proposal to include the Darwin Mid Suburbs Area Plan, as altered, in Schedule 2 to clause 2.7 of the NT Planning Scheme, is suitable because it furthers an integrated strategy to appropriately accommodate the needs of future populations. Principles, concepts and acceptable responses provide context, confidence and clarity for the community, government agencies and developers regarding the appropriate location of new development within the broader framework of the Compact Urban Growth Policy and Darwin Regional Land Use Plan.
